President Trump,

We are William Binney, former Technical Director of the National Security Agency (NSA) with over 36 years experience and the inventor/designer of the main programs used by NSA today, and my wife, Dr. Katherine Horton, expert in international secret service criminality, former particle physicist and former Research Fellow in Physics at St. John's College, University of Oxford, in the UK. I am the man whom You asked CIA Director Mike Pompeo to talk to regarding the Russiagate Hoax as his people were lying to him while I had obtained the forensic evidence that the DNC hack could not have been committed by Russian hackers, but was instead an inside job with hallmarks of a CIA program called *Marble Framework*.

Mr. President, following the two assassination attempts on You, which filled us with horror, we would like to submit most urgently a **Security Report** to You that comprises important information that You and Your Secret Service Detail Leader Sean Curran absolutely need to be aware of going forward. The contents of the Report are **confidential and highly sensitive** as they make reference to covert weapons capabilities of the United States and NATO that are being deployed against civilians with impunity. It is part of the *Standard Operating Procedure* of those who wish you harm to use advanced covert weapons when attempts with conventional weapons have failed. It is of utmost importance that You receive this information as quickly as possible as Your adversaries move fast and like to use the element of surprise.

Therefore, we kindly ask You, Mr. President, to allow us to submit a ring binder with our Security Report to You, as well as an exact copy for Your trusted Secret Service Detail Leader Sean Curran at Your upcoming rally in [REDACTED]

We do not request a personal meeting as we do not wish to impose on Your busy schedule but we have to hand the two binders over in person to an individual of Your complete trust like Your Detail Leader Sean Curran to ensure the chain of custody for the information we provide.

We apologize for the very short notice. Our Report was intended to be submitted to You by the end of September, but the latest incident in West Palm Beach on Sunday rushes us to hand it over as soon as possible. We discovered that You will be speaking in a location near us in a few days, which gives us just enough time to complete the write-up. I am a double-amputee in a wheelchair and find it therefore difficult to attend the rally itself as it would involve hours of queuing. Therefore, we kindly ask that we may be permitted to drop off the binders at the outer security perimeter and would be extremely grateful if Your Detail Leader Sean Curran (whose name we know from an article by Susan Crabtree) or someone authorized by him whom we might recognize as part of his team could receive it from us.

Due to the facts uncovered by our investigation and presented in our Report, the only Secret Service agents in whom we have complete trust are those five who, without hesitation, stormed the stage and protected You with their own bodies while bullets were flying overhead in Butler, PA, on July 13th.

Our Security Report covers several issues. The first part pertains to the assassination attempt in Butler and the network that orchestrated it. **Forensic analyses of the incident pinpoint multiple individuals who were involved and appear to work for US intelligence as agents or assets.** The identities can be discovered from the videos we have of these individuals. Additionally, on September 6th, my wife discovered a **coded announcement of the attempt on Your life** made exactly 3 months and 3 days before the event. It uses the same code as a death threat that my wife received on July 21st apparently in retaliation for her investigation of the incident in Butler, which we reported to our local police as a credible threat since it follows multiple assassination attempts that my wife survived in the past.

My wife, who is not just my “+1” but an international investigator and expert witness in her own right, has done extensive research into the *Physics of Complex Human Systems* and the phenomenon of *Deep Capture*, by which human systems get taken over and subverted by bad actors and criminal networks. After leaving the University of Oxford to start her own business, she came under attack by European intelligence agencies for reasons that were unknown to her at the time. During the investigation of the crimes against her, she uncovered that she had been covertly and non-consensually implanted with military biotechnology by her *alma mater*, the University of Oxford, during her years as undergraduate. She uncovered that Oxford was one of the leaders in the development of military biotechnology for the so-called *Super Soldier* programs of our government and NATO and was using its students for covert, non-consensual human experimentation and sex trafficking to people in public life. She obtained proof of her implants in scientific measurements at a university in Belgium and has been litigating against British intelligence since 2016. I met her as part of my investigations into crimes being committed by our intelligence agencies against civilians and whistleblowers like me. We've been married since 2020.

The second part of our report is dedicated to the **modern, covert weapons systems that very likely will be unleashed on You, Mr. President, and Your Secret Service detail** if other methods of preventing Your reelection fail. We speak with certainty and experience as these weapons are currently being used on many thousands of innocent Americans and Europeans, including my wife and myself.

In my former role at NSA, I was the *Technical Director of the World Geopolitical and Military Analysis and Reporting*, which was the highest technical position for analysis and reporting at NSA. Nonetheless, I was not aware of these weapons systems until they were used against my wife and me. This is as a result of the complete take-over of our intelligence agencies by a Transnational Criminal Organization, often referred to as the Deep State or the Globalists, which has been hoarding all advanced technologies for its own use on its perceived enemies, while withholding knowledge of the existence of those technologies from the American people and its genuine leaders who are not part of that cabal. Our Report contains information on that vast criminal network as it has been mapped in recent years.

Crucially, our Report also includes my **proposal for a technical framework that would allow You to identify and isolate bad actors very quickly and cheaply.** At NSA, the architectures that I developed and left NSA with revolutionized NSA's capabilities at a fraction of the cost that it was spending on failing programs. When the potential of my approach was discovered, several of my inventions were stolen and turned into very profitable companies without my knowledge or consent. Meanwhile, I was maliciously blocked from implementing those programs that would have unmasked criminal activity in government and auditing programs that would have revealed the efficacy and return-on-investment (or lack thereof) of NSA's programs. Senior leadership, with training exclusively in management and with minimal to no technical know-how, told me to my face that “*You will never do this program!*”.

Finally, our Report proposes a **simple and extremely cheap way of securing our elections for good.** The scheme would be independent of a second and much more sophisticated **real-time monitoring** that I propose that I could implement with capabilities that I used to have at my disposal. My design could **pick out fraud live** the moment it is attempted and **alert poll workers and authorities automatically.**

Mr. President, we would like to express our deepest gratitude and respect for Your work to restore this country to its former glory and make it once again an economic powerhouse for the American people. We cannot express how desperately Americans in general and especially victims of the intelligence agencies need Your help in eliminating the Deep State and how much faith we have in You to do so.

My wife has been a supporter of Yours during Your first presidency even though she lived in Europe at the time and had no intention of moving to the US back then. She is an ethnic Hungarian who fled Communist Romania as a child with her parents and grew up in Germany. She often says that she has “*seen this movie before*” when talking about what is being done to the US and is a fan of Victor Orban who restored Hungary to its former beauty, and who in turn is an admirer of Yours – likely because he understands better than most the challenges you face and the benefits your victories have for the world. To my wife's amusement, she was reprimanded by an FBI harassment agent, who was trying to defame her publicly, for being “*MAGA*”. My wife jokes that it's a good thing that the FBI does not know that she is in fact “*Ultra MAGA*” or else she might get arrested. She got me a signed copy of your book *Save America* for my birthday as a symbol of the extraordinary times we are living through together. I, on the other hand, have only ever donated to one political candidate in my entire life and it is You.

President Trump, we have complete trust in You, support Your policies and wholeheartedly share Your vision for America. We have complete faith that You will win the election a third time this November.

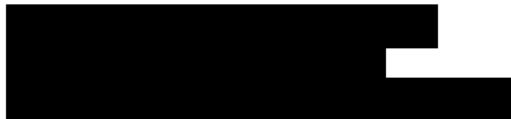
