Dear Mr. Curran,

William Binney, ret. Technical Director of NSA, and I his wife sent a letter to you and President Trump on September 18th with an urgent message, but didn't get a response. Intelligence agencies habitually infiltrate front offices and divert mail. So unless you respond and tell us that you do not wish to hear from us, we have no way of knowing if our letters got through. This second letter is in response to President Trump's directive to "*never ever give up... just never quit*" when standing up for what is right. Thus, I feel not just compelled but also ordered by our Commander in Chief to try once more, not least since the life and well-being of many people depend on us getting through to you and President Trump.

The President is already busy meeting international leaders and you are also tied into those activities. However, you must find a way to accommodate me at some point, either along your duties or on your days off, if such days exist, and rely on your personal initiative to engage in this matter because it is of utmost importance. I say that as a scientist who doesn't know days off when I am working on projects.

The issues that I urgently need to talk to you and President Trump about concern the following 4 topics. They might seem far-fetched, even outlandish to you but I assure you that every single one is very much your immediate and ongoing problem that you have to concern yourself with as soon as possible:

1. The **assassination attempts on President Trump** and the forensic evidence that implies that they were committed by the FBI (and CIA but the two are the same network behind the scenes). This has implications for the measures that must be taken to keep your protectee safe in future.

It also means that the memorandum of understanding between FBI and Secret Service must be canceled and it is the Secret Service that has to investigate the assassination attempts on Trump. If you leave it to the FBI, you leave it to the perpetrators. The result will be the lies we've seen.

I have found the announcement of the first assassination attempt using the *Ace of Spades* (known as the Death Card), 5 people in the crowd in Butler with foreknowledge of the shooting, the "All-Systems-Go" signal given to the shooter and the announcement of that "All-Systems-Go" sign to insiders ahead of the Butler rally. I also found what looks like the kill order to take out President Trump before Inauguration Day. Some of those leads point back to Trump's team. Therefore, you must investigate those leads yourself immediately instead of waiting on the FBI.

2. Use of **Directed Energy Weapons** on President Trump's supporters, nominees and eventually his family and him. The Secret Service has almost no knowledge of these devastating weapons, the signs to look for and what evasive actions to take when under attack. In contrast, the FBI operates a vast fleet of cars carrying these weapons and is gunning people in the street while the Air Force is using visually camouflaged drones to gun Americans inside buildings and homes. This is part of the FBI's so-called *Targeted Individuals* program, essentially COINTELPRO 2.0.

There is indication that Directed Energy Weapons were used on Trump supporters hours after Bill and I sent you our first letter on September 18th. Rally goers in Arizona reported burning in their eyes and temporary blindness after leaving the rally, which implies that they were attacked by the FBI's weaponized cars on their way home. Targeted retaliation 'echoing' our endeavors to warn authorities is par of the course with the FBI. What also needs to be investigated is the sudden death of the owner of Gottlieb's Deli in New York a few hours later that led to President Trump canceling his trip to Brooklyn to meet the Deli's owners. DEWs can cause instant death.

3. Use of **covert, non-consensual, remote-controlled biotechnology implants** in the population, esp. in military and security personnel, which can be weaponized against the Secret Service and the protectee. It sounds fantastical but the existence and proliferation of such implants is proven scientifically. There are incidents that imply that those implants are already being 'tested' on SS.

There is a relatively quick and easy way to find those covert implants. You have to scan your staff and yourself because there is a high likelihood that some of you have been implanted. As bat-shit crazy as that sounds, Americans, especially soldiers, have been implanted for decades. I can show you videos of public figures showing obvious effects of remote-controlled implants. Dr. Staninger's book *Global Brain Chip and Mesogens* has photos of implants found in victims.

4. The **technical requirements for the investigation** of these crimes and for the discovery and dismantling of the criminal network that is known as the Deep State, and the steps one has to take to **run an investigation or protective mission in a situation known as *Deep Capture***.

Secret Service leadership doesn't have the faintest clue how to run an investigation and what capabilities are available. This is betrayed by the fact that SS Director Cheatle collected the cell phones of SS agents who were in attendance on January 6th and deleted their text messages. She had no idea how futile that endeavor was as every text message, phone call, email and video call ever made anywhere since 2001 is being collected and stored by NSA forever. So deleting text messages from the users' device doesn't make a difference, the messages are still available.

Using NSA's capabilities and databases, there is a way to uncover the vast majority of criminal operations anywhere in the country while protecting American's privacy. The network behind the assassination attempts can be unmasked with the same ease as illegal immigrants, human trafficking and election fraud. The expert on how to do that is William Binney. NSA dismantled his program that was uncovering criminal activity and forbade him from implementing it again.

After losing both his lower legs in bioweapon attacks, Bill Binney is being tortured to death with non-consensual implants that were put into him during the amputation of his legs. I am fighting round-the-clock to keep him alive and thwart the FBI and Air Force's non-stop attacks on us, but I need help from President Trump. And the President needs help from Bill Binney because none of his otherwise excellent nominations have the technical skills required to uncover criminal networks. Those networks are closing in on all of us, including your protectee.

Elon Musk, in whom the President is placing a lot of trust, seems to be a front of the military-industrial complex. All his companies are focus projects of NASA, DARPA and the globalists. That's why he could take a month off to campaign for Trump, because he is not actually running the show. In Butler, Elon Musk announced that he is "*dark and Gothic MAGA*" while wearing a black hat (a coded reference all techies will recognize), jumped around behind President Trump on the stage so the press photos could show him "eclipsing" Trump, and his 4-year old son blurted out in a Tucker Carlson interview that the goal is to "*quietly just do whatever we want*", a complex phrase that the young kid must have picked up from his father. Elon Musk and his companies do not have the expertise and technical skills (much less the inclination) to uncover the vast criminal network in the US that is known as the Deep State. Meanwhile, Bill Binney had that system up and running for 1/1000th of the cost of NSA's alternative programs in 2001.

The way all this relates to you and President Trump is that your protectee needs to watch for proverbial snakes in the grass and take what he is being told with a pinch of salt and pepper. You, on the other hand, find yourself in a situation known as Deep Capture whereby you have to assemble an investigative team from trusted contacts. You cannot leave it to senior leadership since in capture, the higher one goes the corrupter it gets – by the laws of systems physics!

The material that I would like to present to you is **not classified, but confidential** as it pertains to

investigations that have to be conducted, ideally by SS. I need **3-4 hours** to leave you with a working knowledge of these topics that will put you far ahead of your colleagues and international counterparts.

The covert technologies seem outlandish at first, but once you know what to look for, there will be cases over the coming months that you will recognize and interpret correctly for the threats they are. I guarantee that it will be the case since that was Bill Binney's experience after I taught him what I know. It's crucial that you are able to recognize those threats in time and forestall attacks, not least because there is very little in the way of shielding or protection from some types of Directed Energy Weapons.

There are rumors that you might be nominated to become the next Director of the Secret Service, an appointment that I wholeheartedly support based on my analysis of Trump's protective detail since Butler, which indicates that you are the best man he's got (although it's not my place to comment). However, I get sick to my stomach at the prospect of President Trump not having you by his side when you become Director as the evidence suggests that the coming months and first years of his presidency will be the most dangerous time of his life. Either way, you will have to educate yourself about the use of these modern stealth weapons if you continue as Trump's protective detail leader, engage in another protective mission or become the Director of the Secret Service. Whichever path you take, you will become exponentially busier in the coming year than you already are. So now might be the best and perhaps only opportunity to carve out some time to learn about these covert technologies.

I realize that my approach is so out of the blue and unconventional that if I leave it to you and Trump you'll likely do what all guys do, which is to simply ignore it. Regarding the fact that I'm not from the usual channels that supply you with information, I would like to remind you of another directive from President Trump to *"relish the opportunity to be an outsider. Being an outsider is fine, embrace the label, because it's the outsiders who change the world and will make a real and lasting difference"*. I would like to point out that your organization has undergone a systemic dumbing-down that I am sure hasn't escaped your attention and that was by no means accidental. The Independent Review Panel complained in October that the *"Secret Service has become bureaucratic, complacent, and static even though risks have multiplied and technology has evolved"*. If you want to reverse that course you can take proactive, dynamic and innovative action to learn about those new technologies right now:

I will go to the **South gate of Mar-a-Lago (next to the watchtower) at 10am on Monday, Dec. 9th**. If you meet me at the gate I give you the write-up that Bill and I have compiled for you and the President. If you grant me 3-4 hours and somewhere we could sit. I teach you what you need to know so that you will be far ahead of the leadership of all government agencies. Please don't brush this off. Several hours seems a lot to take out of your day, but I will give you the information that took me years to assemble and that the intelligence community and military will continue to keep from you because they want those capabilities to subjugate the Secret Service and sabotage your protectee.

I will **wait until 10:30am** and then leave if I you don't meet me there (and probably curse you forever). If you are not there that day or prefer another day, please let me know using my contact details below.

I understand that your time is extremely valuable and you cannot throw away half a day for nonsense. Therefore, I would like to make you the following offer: I attach a **check for \$1,000 as guarantee**. If you tell me after our meeting that it was the biggest heck-almighty waste of your time and that I'm a total fool and kook, you get to cash the check as damages and tort payment for the 4 hours you wasted on me and merry Christmas! If however, you decide afterwards that your time was well spent and that you're glad that someone gave you all that detailed information free of charge, because Secret Service leadership sure as hell weren't gonna, then I get to keep the check (and I am off Christmas shopping!).

I encourage you to consider time spent on these issues an important investment in your future career. These modern weapons are unfortunately not going away and Directed Energy Weapons are the fastest-growing market for arms and worth over \$40bn by now. Secret Service leadership is unlikely to put on a training course to explain the terrifying effects of these weapons, not least because they have no clue.

I know this for a fact as William Binney was in charge of global intelligence monitoring at the highest technical level at NSA and yet, he didn't have any idea about the true capabilities of DEWs and covert implants before I came to the US and showed him the evidence I had collected over years.

If that doesn't sway you, I would like to quote a male victim who watched one of my YouTube videos on Directed Energy Weapon attacks and months later contacted me to tell me that I had "*saved his life*". He suffered an attack that unfolded exactly the way I described and he survived thanks to my advice. I hope that you and your protectee never find yourself in that situation. However, if you do, I want you to have all the information that I assembled from my own and other victims' years of experience.

This trip takes not just enormous courage on my part, it's also extremely dangerous as the FBI retaliates against every step Bill and I take to publicize their use of these weapons and the plight of their victims, e.g. there are indications that the FBI retaliated against others for our 1st letter we sent you on Sept. 18th, as mentioned above. What makes things harder is that Bill is a double-amputee. So I am not just his wife but also his full-time disability assistant and his personal security detail, whereby I have to try to do what you do without your build and training.

I cannot take Bill with me for such a long and possibly futile trip. Nor should we make the trip by air as the intel agencies have recently downed a plane over Brazil, said to be carrying doctors on their way to a conference to present that the vaccine itself is the origin of 'long-Covid'. What we'd like to tell you is a lot more damaging to the intelligence community than the truth on the Covid shots is to Big Pharma. So if the intel agencies take me out, I'd rather they hit my car than an entire plane load of people. But if I go alone I have to leave what is essentially my protectee behind, not knowing what they might do to him. I hope you see how high the stakes are for us and how important the info is that we want give you.

It is understandable if you are suspicious, incredulous and dismissive of my offer of information or me. I can assure you that I have top qualifications in high-energy physics (1st class Masters & PhD) from the University of Oxford that is relevant to the topic of Directed Energy Weapons and body implants. For several years I worked as a research fellow at Oxford and as a particle physicist at the largest particle accelerator laboratories in the world, namely CERN in Switzerland and DESY in Germany.

Subsequently, I spent over a decade investigating secret service criminality. I conducted scientific measurements of victims' covert, non-consensual implants in Belgium and Switzerland. I provided consulting and counseling to countless victims, some of whom are high-profile individuals like judges. I testified as an expert witness in victim's court cases in France, Switzerland and Belgium. I survived several assassination attempts by the intelligence agencies in retaliation for my work. Most recently, the FBI sent me a coded death threat on July 21st because I investigated the first assassination attempt on President Trump and uncovered several people with foreknowledge of the shooting in the crowd. That death threat was reported to our local police. I survived the assassination attempt that followed that threat on November 9th, which was a knock-out shot with a so-called Pulsed Energy Projectile to the head fired from a drone above our house. Bill survived an attack exactly a week later to the minute.


I never worked for an intelligence agency. I am not an agent or honey pot. I am most certainly not a "Russian agent" as my parents and I fled Communist Romania as ethnic Hungarians when I was a child and there are official records that prove that we were victims of Romanian intelligence, the *Securitate*, because my parents and grandparents were dissidents who didn't go along with the Communist system. After we fled to Germany in the 1980s, we were naturalized as German nationals. I went to school in Germany, where I skipped a year on merit and came top of my year. I was then educated at Oxford. As I am European, I've also never used a gun and don't possess one. I am basically harmless and lovely.

Most importantly, I am not bound by official secrecy or Non-Disclosure Agreements, which is why I can talk freely about the weapons and crimes committed by the intelligence agencies. The information I have comes from my own research and the evidence that I have collected and thus cannot be classified.

Please, do take the time to meet me next Monday at 10am by the Mar-a-Lago South gate. I am hoping that if I can prove to you how crucial those topics are that President Trump will meet with Bill Binney. It's important because Bill is the only one who can use the NSA databases to uncover the Deep State. He designed the whole damn system! None of Trump's current nominations have the skills to do that, nor do they know how the system works, what information there is and where to find it. We urgently need President Trump to stop the intel agencies as they are torturing thousands to death, including us!
