

# To the Attention of Secret Service Director Sean Curran

U.S. Secret Service, Washington, DC

Dear Director Curran,

We, William Binney and Dr. Katherine Horton, have been trying to contact you since September 2024. Bill is a retired Technical Director of NSA and an internationally known NSA whistleblower and I am a former particle physicist and investigator of intelligence agency criminality in Europe and the US. We wrote two letters addressed to President Trump and you personally in September that seem to have been stolen by the FBI. We wrote a second letter at the start of December announcing that I, Katherine, will try to hand in evidence regarding the assassination attempts on President Trump to you personally at Mar-a-Lago a week later. When I reported to the South gate of Mar-a-Lago at the stated time at 10am on December 9<sup>th</sup>, your Secret Service colleague told me that there was no record of any letter from me. That was rather interesting as I sent all letters with UPS tracking and the 2<sup>nd</sup> letter to you was received and signed for by “*Secret Service*” at Mar-a-Lago on Dec 3<sup>rd</sup>, according to the tracking information.

What was even more intriguing is that on my drive from our home to Florida the day before on Dec 8<sup>th</sup>, our car was sabotaged so that the plastic underside detached unexpectedly and scraped across the road and later on, a hit squad consisting of 5 sports car and a jeep was trying to conduct what looked like the PIT maneuver on my car at 70mph on I-95. After I spoke to your colleagues at Mar-a-Lago, a surveillance car was parked as overtly as possible outside the house I was staying at a mile from Mar-a-Lago in West Palm Beach and our car was sabotaged 2 more times before my departure.

Long story short, the FBI seems to be working hard to prevent us from getting our information to you. If nothing else, that serves as an indicator that *they* at least are taking us seriously. In the hope of you doing the same at some point, I would like to endeavor to submit our bundle to you one more time. After all those failed attempts and having obtained concrete proof of our mail being stolen by FBI plants, I have to insist on handing the ring binder that we have prepared for you over to you personally. For this reason, it would assist me greatly if you would be kind enough to meet me at the entrance or **the reception of the Secret Service building in Washington DC next Monday, April 7<sup>th</sup>**. It's just a ring binder that contains the facts and evidence you need to be aware of and a little thumb drive with photo and video evidence that goes with the information provided in the binder. Apart from the danger of innocent paper cuts, there is no threat emanating from that ring binder and I too am totally harmless.

In summary, the binder contains

- suggestions on data the intelligence community can provide to assist your protective mission,
- suggestions on the Memorandum of Understanding between the Secret Service and the FBI,
- important evidence regarding the assassination attempts on President Trump relevant in future,
- FBI death threats against protectees and assassination attempts on investigators,
- evidence of the repeated theft of your mail by FBI moles and FBI retaliation against the authors,
- modern military stealth weapons and their use on the protectees and their associates,
- the proposal of an investigative project to scientifically assess the scale of immediate threats.

I shall report to the **Secret Service Headquarters at 950 H St NW #7800 at 10am Monday April 7<sup>th</sup>**. The HQ in H St seemed to be the most likely place where your office would be. However, should I not find you in H St because your office is actually located in the new building by the river, I shall make my way there and **endeavor to be at 245 Murray Ln SW between 11am-12pm, traffic permitting.**

Should you be away from the office or out of town on April 7<sup>th</sup>, I very kindly ask you to notify Bill and me via email or phone, see our contact details below.

Our meeting can be as short or as long as you wish it to be. We prepared the bundle such that you can go through it at your leisure. If you prefer, I can just hand over the binder in a 2min exchange. Or if you have a little bit of time, I can give you a run-down on what's contained in it and some background info, which would take about an hour. Beyond that, I am entirely at your service to elaborate on contents and the investigation that we propose in any detail you are interested in. Unfortunately, I will have to leave Bill Binney at home for this trip as the journey is somewhat dicey given my past experience, but he is also at your service in any capacity you wish at any time.

Please allow me to emphasize the urgency and extreme importance of the matters we would like to discuss with you. The truth is that Bill Binney and I, along with other investigators, are under attack by US intelligence agencies as well as the Air Force via a covert drone program, which continues unabated even under the new Trump administration. It will require a concerted effort by President Trump, FBI Director Kash Patel, Assistant Director Dan Bongino, Director of National Intelligence Tulsi Gabbard and Secretary of Defense Pete Hegseth to get the intelligence agencies and the military under control, as they are all engaged in a covert nationwide surveillance, torture and murder program. During that phase, the Secret Service will have to work overtime and be top of their game to keep their protectees safe because indications are that things are going to get a lot worse before they get better.

When people like Bill Binney and myself try to reach out to those in charge with the facts that have been withheld from them by their own agencies, the retaliation by the FBI and Air Force are brutal. Assassination attempts like the one I dodged on I-95 on my way to West Palm Beach are unfortunately par of the course. So every trip I take to get our information to people is like playing Russian Roulette, and I really would like to stop spinning the barrel and pulling the trigger and finally get through to you.

Please, Director Curran, if you give us the time of day, we promise to make it worth your while and serve your agency and you to the very best of our ability.
