Subject:

- **Immediate Risk to Health and Life for the neighbours**
- **Illegal testing of military weapons, especially microwave weapons since January 2016 in Unterengstringen and other regions of Switzerland, e.g. Biel**
- **Targeted, premeditated bodily harm with the aim of illegal military exercises, human experimentation and with intention to commit murder to minimise claims for damages**
- **Threat to national security, several thousand similar cases in Switzerland and hundreds of thousands internationally in preparation for an international genocide**
- **State terrorism and refusal of the police to investigate and stop the perpetrators**
- **Cease and desist demand to the perpetrators**

Dear neighbours,

I am contacting you in order to inform you about an immediate danger for your health and that of your family. **Please keep this letter as a document for court use in future litigation** as you might have suffered damage to your health and that of your family and pets for which you can take legal action against the Swiss State, especially the Secret Service and the military, in a national court or in international courts as crimes against humanity without a limitation period.

With this letter, I would like to satisfy my legal and moral obligations and draw your attention to the fact that electromagnetic weapons have been in use against the civilian population in Unterengstringen and the surrounding area since January 2016. These appear to be large-scale weapons tests, military exercises and human experimentation of the Swiss military and the Swiss Intelligence Agency, *Nachrichtendienst des Bundes*, NDB. The conduct of these military exercises is highly criminal and is mostly aimed at the Swiss population.

About Me

I am contacting you as your neighbour and with my qualifications as a high-energy physicist with several years of experience in fundamental research at CERN in Geneva and at DESY in Hamburg, and as the leader of an international criminal investigation team, the *Joint Investigation Team US-Europe*, which investigates the illegal use of *Directed Energy Weapons*, military neuro- and biotechnology, as well as systemic corruption. 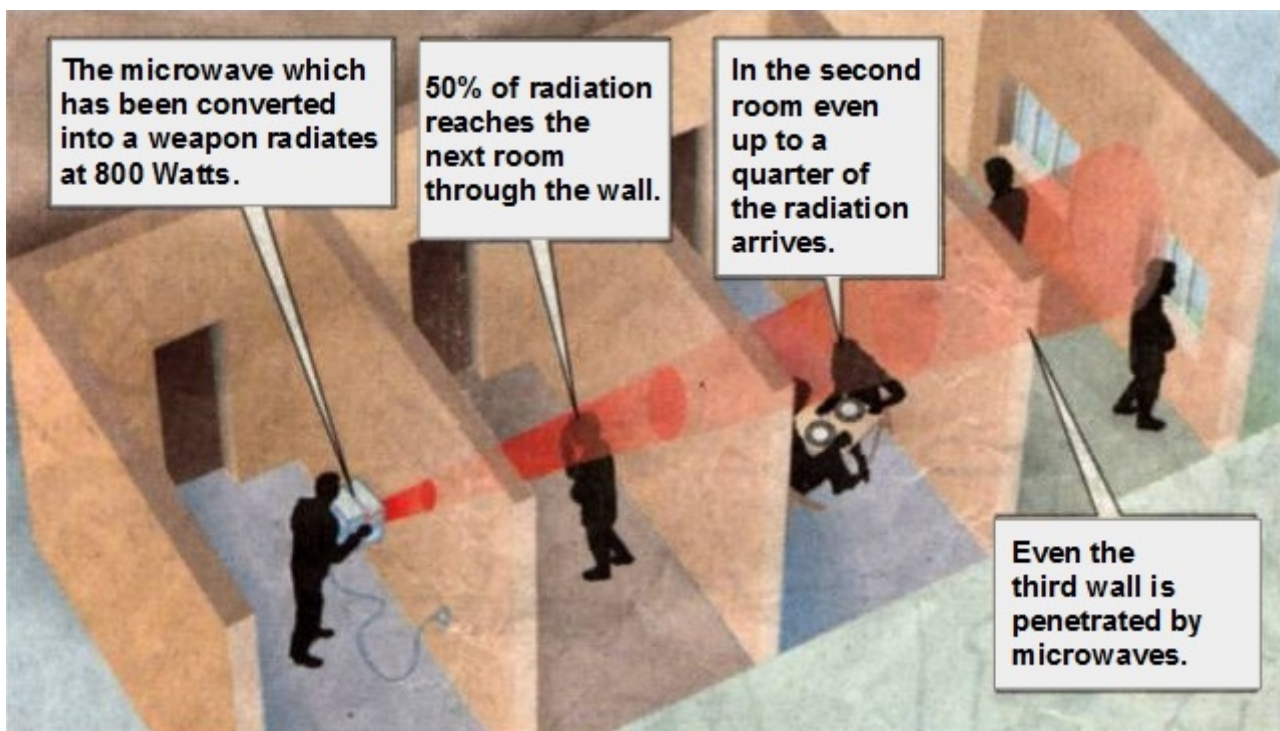

Electromagnetic Weapons

The weapons which are in use in Unterengstringen are known as electromagnetic weapons, radiation weapons, microwave weapons, *Directed Energy Weapons* and as *Non-Lethal Weapons*. The latter name is misleading as these weapons can cause cancer, organ and brain damage and with time can cause death. The physical damage is initially hidden, but has devastating consequences long term.

Electromagnetic weapons can shoot through several walls and do not leave impact holes. That is the case as 50% of microwave radiation passes through walls, see image below. This is the reason why one can use mobile phones in the cellar and why tenants in blocks of flats can use the Wi-Fi of their neighbours. For this reason, kitchen microwaves have to be entirely shielded with metal and the viewing window has to be covered in a metal grid in order to reflect the radiation inward.

What many don't know is that the radiation that is used for wireless internet and other applications can also be used as a weapon at high intensity and with tight collimation. It is particularly damaging when the energy is bundled into high-intensity pulses. By generating such pulses with lasers one can even break away or evaporate metal, a process that is known as *Laser Etching* or *Laser Welding* in the industry.

Based on this physical effect, a new type of weapon was developed in the 1950-70s with which one can attack victims through walls and therefore also torture, injure and murder them within their own homes. These weapons have been kept classified for a long time, but are now being manufactured in large numbers and at very low cost, and are being used covertly against civilians. You can find more information on electromagnetic weapons and the related sonic weapons on the internet.

Examples of larger-scale electromagnetic weapons are lasers used by the military to shoot down rockets, and the *Active Denial System*, a microwave weapon, which was used for mass murder in Iraq and is, worryingly, also used against civilian protests. Smaller models of electromagnetic weapons, which also cause physical harm, fit into rucksacks and handbags. One can even modify standard kitchen microwaves and use them as radiation weapons. The global market for electromagnetic weapons is expanding rapidly and is predicted to increase fivefold from \$8bn to \$42bn between 2016 and 2023¹.

Health Damages due to Electromagnetic Weapons

As mentioned above, the main health damages arising from the use of electromagnetic weapons are tumour formation, cancer, organ and brain damage. I would like to draw your attention specifically to the fact that babies, infants and the elderly above 60 years of age are particularly vulnerable to the radiation damage. Young girls and women of reproductive age are particularly in danger as radiation weapons damage the female egg cells which are already formed in the ovaries at birth. This can cause DNA damage which degenerates the X-chromosomes permanently for all subsequent generations².

Should you have suffered unusual pain or other strange symptoms since January 2016, especially, headaches, joint aches, heart or heart rhythm issues, digestive trouble, problems with eye-sight, sleep deprivation, neurological complaints, tumours or cancer, then you should pay particular attention to the information provided here. Radiation weapons can also cause sudden depression, difficulties concentrating, unusual memory impairment, changes in personality, tiredness, sudden aggression and atypical mood swings.

Should you know of instances of death within the danger zone (see attachment) then those cases should be investigated with view towards a possible connection to these weapons test and military exercises. The investigation of my team has indication that Western Secret Services often commit murder in order to vacate flats or houses for their purposes, and to cash in on fraudulent life insurance policies on the victim which have been entered into without the knowledge of the victim. Equally, victims are murdered to avoid claims for damages. For these reasons, the deaths in this community from 2015 onwards have to be investigated.

Furthermore, sudden changes in behaviour, health issues or death in pets, including the disappearance of pets, can result from these weapons tests. The torture or injury of pets is equally actionable as property damage to for example cars or house walls.

Weapons Testing in Unterengstringen

I have been a resident of Unterengstringen since September 2015. Starting from January 2016, I have been attacked with electromagnetic weapons around the clock. These shots can be measured and I have uploaded numerous evidence videos of measurements of these attacks to the internet, see my website <https://stop007.org> under “*Evidence*”. I have also made countless videos about injuries which I suffered as a result. The attacks are particularly intensive during the night such that I wake up with fresh bruises on most mornings.

The attacks appear to come from the neighbouring houses, whereby it should be noted that I am being attacked from all directions, which means that **at least 4 neighbours have to be involved in these crimes.**

Only homes with a direct line of sight onto my flat in Langacherstrasse 6 are candidates for the source of the attacks. That is the case since electromagnetic projectiles travel in a straight line.

It is extremely difficult for civilians to determine the source of electromagnetic attacks. The reason

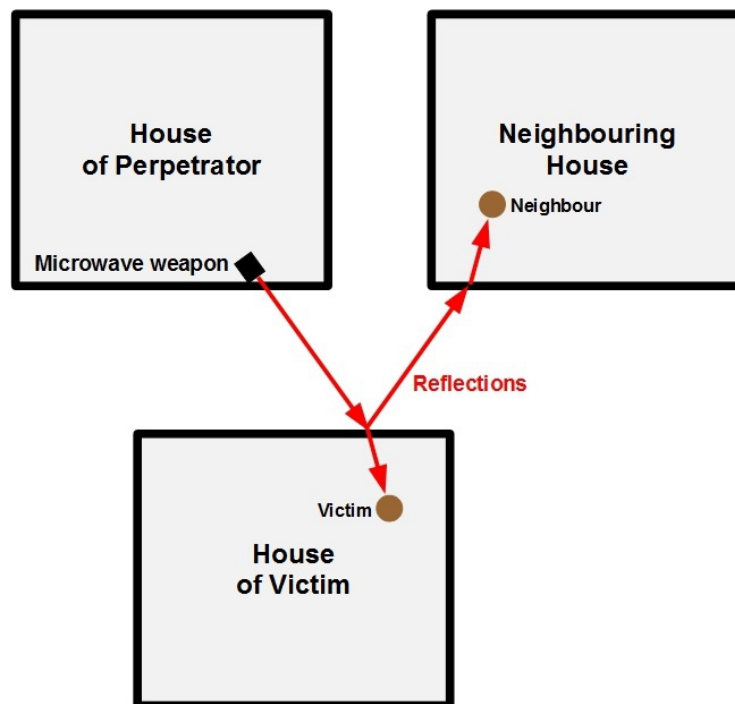
for that is that these weapons fire pulsed shots which do not leave impact holes and travel at the speed of light. It is, however, not impossible and thus I have succeeded in identifying the likely perpetrators. This is now part of covert investigations.

Cease and Desist Demand

For this reason, I am hereby delivering a demand to the perpetrators to cease and desist the physical harm and the aiding and abetting of covert murder immediately. Due to the ongoing investigations, which are also of international consequence, I cannot identify the individual perpetrators at this stage. For this reason, I am addressing the entire neighbourhood, whereby I assure those neighbours who are innocent that I do not suspect anyone without cause or proof.

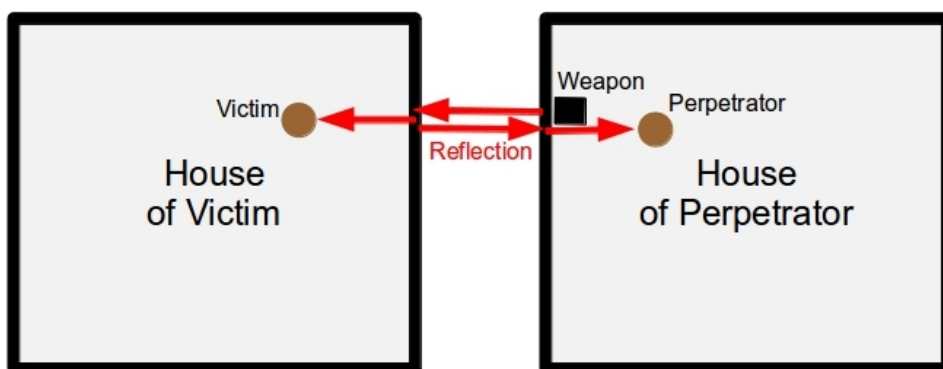
Threat to National Security

I also would like to warn those neighbours who are innocent and who have a direct line of sight onto my home that they too are affected by these crimes. This is the case as 50% of the radiation is reflected by the house walls and scatters into the surrounding houses which have a direct line of sight onto my home. This means that certain neighbours who live within the angle of reflection from the perpetrators have also been intensely irradiated in the past 2 years, see diagram below, and can as a result develop cancer or other health problems like me. Due to the devastating long term effects of the irradiation it is therefore very important that you keep this letter since you have a right to damages even after 5, 10 or 15 years.

In the case of a frontal attack, the perpetrators are irradiating themselves with the same dose as the victim, see diagram below. The irradiation of the perpetrators is part of the military plans and is intended to destroy the main witnesses of these crimes at the same time. Furthermore, our investigation has indicated that very often a second ring of perpetrators is set up around the initial perpetrators themselves who are then covertly irradiating these in order to shorten their lifetime. This, as well as the targeted irradiation of the neighbourhood is part of large-scale genocide plans of the Western governments, see the section below, which deals with these issues.

Denial of Help from Public Institutions

Claims for damages can be addressed to the Swiss military and the Swiss Intelligence Agency, as well as to the local police since all three institutions have been informed by me personally and have refused all assistance. You can quote that I, Dr. Katherine Horton, have spoken several times to Mr Merz at the military police in 2016 and have informed him of the misuse of military weapons in the civilian domain. On 15. March 2017, I spoke in person with a high-ranking officer of the Swiss Intelligence Agency in the military head quarters in Berne, who confirmed that very many Swiss complain to him about microwave weapons attacks. At the police in Unterengstringen, I have spoken several times with Mr. Schoch and Ms Meyer. The officer in charge of the police station in Unterengstringen is Mr. Wendelin Koch. In addition to the microwave assaults, I had to report several break-ins into my flat. These break-ins are part of the disintegration (“Zersetzung”) campaign of the Secret Services against the victims.

The microwave attacks are the result of state terrorism, or more specifically of criminal attacks of an international network of organised criminals who have corrupted state officials in all European countries and in the USA over the past few decades. For this reason, corrupt officials deny the victims all help.

This has been the case for several decades by now. During that time, the number of victims has steadily increased. In 2007, there were already over 1500 documented cases internationally, which were passed to the Swiss authorities by the Swiss citizen Walter Madliger and the activist John Finch³. International Planned Genocide of the Civilian Population

The investigations of the past year have established that the attacks on the civilian population with electromagnetic weapons, which happen internationally, are being conducted by the Secret Services. By now, it has been discovered that there appear to be **Genocide Treaties** which have been signed by the governments and according to which a mass murder of the civilian population is to be conducted. It appears to be the case that these plans are part of the depopulation of planet Earth in connection to UN Agenda 21 and UN Agenda 2030.

The intelligence organisation *Deagel.com*, which is being used as an intelligence provider by international Intelligence Agencies like the American NSA and other state organisations like NATO, OECD and the World Bank (as can be seen for example in Wikileaks documents⁴), has published the planned genocide rates for the individual countries. According to the forecast, a third of the Swiss population is to be exterminated by 2025. These and other incredibly criminal plans for other

countries can be accessed on the website of *Deagel.com* using the search function for each country.

Part of these genocide plans is the recruitment of corrupts and proletarians in the neighbourhood of the victim. These local perpetrators are very well paid and appear to be given access to the surveillance footage from the private quarters of the victim. The idea behind that is to develop a reliance on the illegal income and an addiction to voyeurism and sadism in the perpetrators. The addiction is then used to incite the neighbours to covert murder with radiation weapons. Slander campaigns are used against the victim in order to smear them as criminals, drug addicts, alcoholics, paedophiles or prostitutes.

Request for Assistance

Our investigative team has been trying for the past year to stop the genocide and the attacks against the civilian population. I am supporting several cases in Switzerland and also internationally as an expert witness, for example the case of Siegfried Tomys in Biel, Switzerland, the case of Frederic Laroche in Grenoble, France, and the case of Melanie Vritschan in Brussels, Belgium. In all cases, the victims are being tortured and maimed the same way by the state. I also had a court case against British Intelligence at the London High Court in 2016, see:

After the first hearing in London, I survived an assassination attempt on me in Switzerland. Since then, I have been mutilated continuously and even more sadistically as previously with electromagnetic machine-guns from the neighbourhood. The psychopathic brutality of the neighbours is only topped by their stupidity. That's because the international comparison shows that the perpetrators are to be murdered in the same genocide in order to kill all witnesses to the crimes.

Despite the fact that we are giving our best, my colleagues and I cannot stop this state criminality without your help. This is especially the case as the perpetrators are being paid large sums from black budgets (presumably from the funds misappropriated from the Swiss social insurance *AHV*, where according to the Swiss whistleblower Harry Heutschi large sums have been removed), and as a result of greed and addiction to power these criminals will not stop the maiming and murder by themselves. For this reason, I ask you to support me in the community, at the local police and at the national level. Should you be aware of the identity of the perpetrators, I would like to ask you to demand from those people that they cease and desist the attacks on me and other neighbours and terminate their cooperation with the state-organised criminality immediately.

One example of how you can assist with the investigations is by keeping an eye on the comings and goings in the neighbourhood, as well as the parking of foreign or continuously changing cars in Langacherstrasse and the surrounding areas. These military programs use civilians, whom they continuously exchange, as stalkers and observers of the victim.

As part of these military programs, young people, pensioners, the unemployed, but also many foreigners are trained in the use of these electromagnetic weapons. We have discovered that flats are rented around the victim which are then used as training centres. These locations flag up as the stream of people who frequent such places change daily. If you could please help me discover these flats then that would be of great help.

My investigation team and I are going to continue to give our best to assist the victims and the civilian population in the battle against this state criminality and the genocide. If you could help us, especially me in Switzerland, with your support and your networks then we have a good fighting chance to stop this megalomania in Switzerland.

To the perpetrators who are taking part in my mutilation and the covert murder of neighbours, I

would like to point out that as war criminals they can be tried and brought to justice in the national courts, as well as in international courts and war crime tribunals abroad with direct consequences within Switzerland. As there is no limitation period in the case of crimes against humanity, it means that **the perpetrators are liable with their private assets for decades to come.**

Finally, I would like to draw attention to the fact that the information provided in this letter, and my precedent setting case as a victim, that of Siegfried Tomys in Biel, as well as that of the late Walter Madliger, could become extremely important for you and your family should you develop health issues as a result of the attacks in Unterengstringen now or during the next decades.

The same applies, should you become the victim of this state criminality at other covert military war theatres of these state programs. For this reason, I ask you to keep this letter and if possible to distribute paper or digital copies to the people in your network. You can download this letter in German and English from my website <https://stop007.org>. It is part of an international campaign in which victims of this genocide inform their communities around the world.

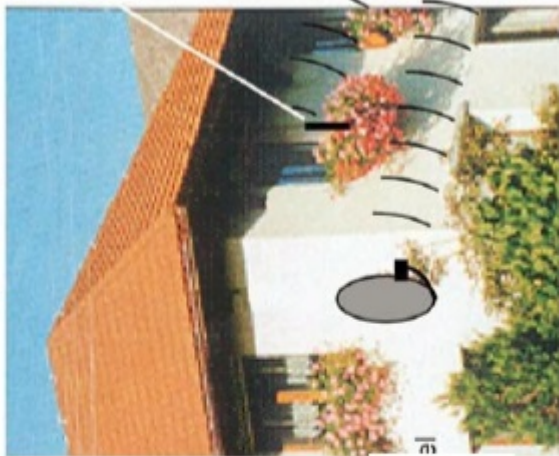

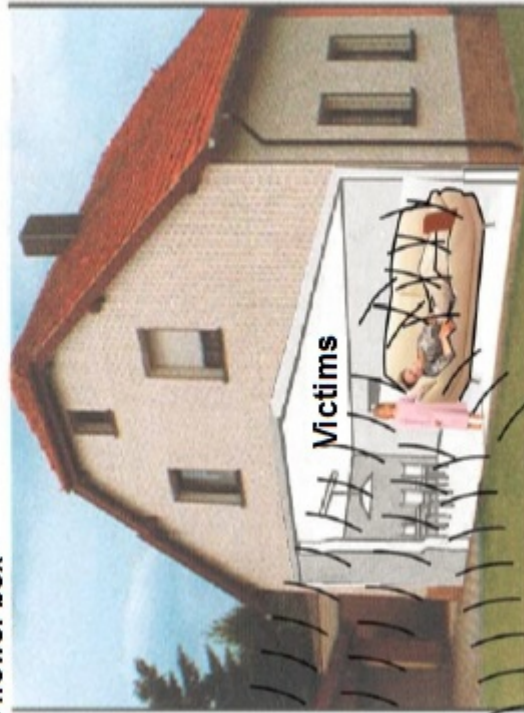

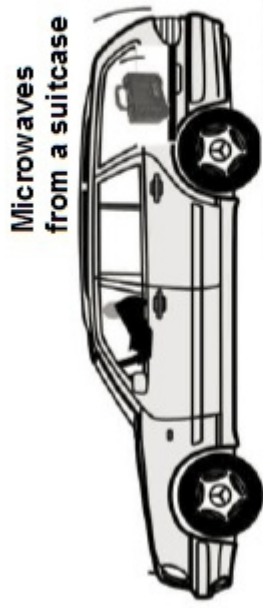

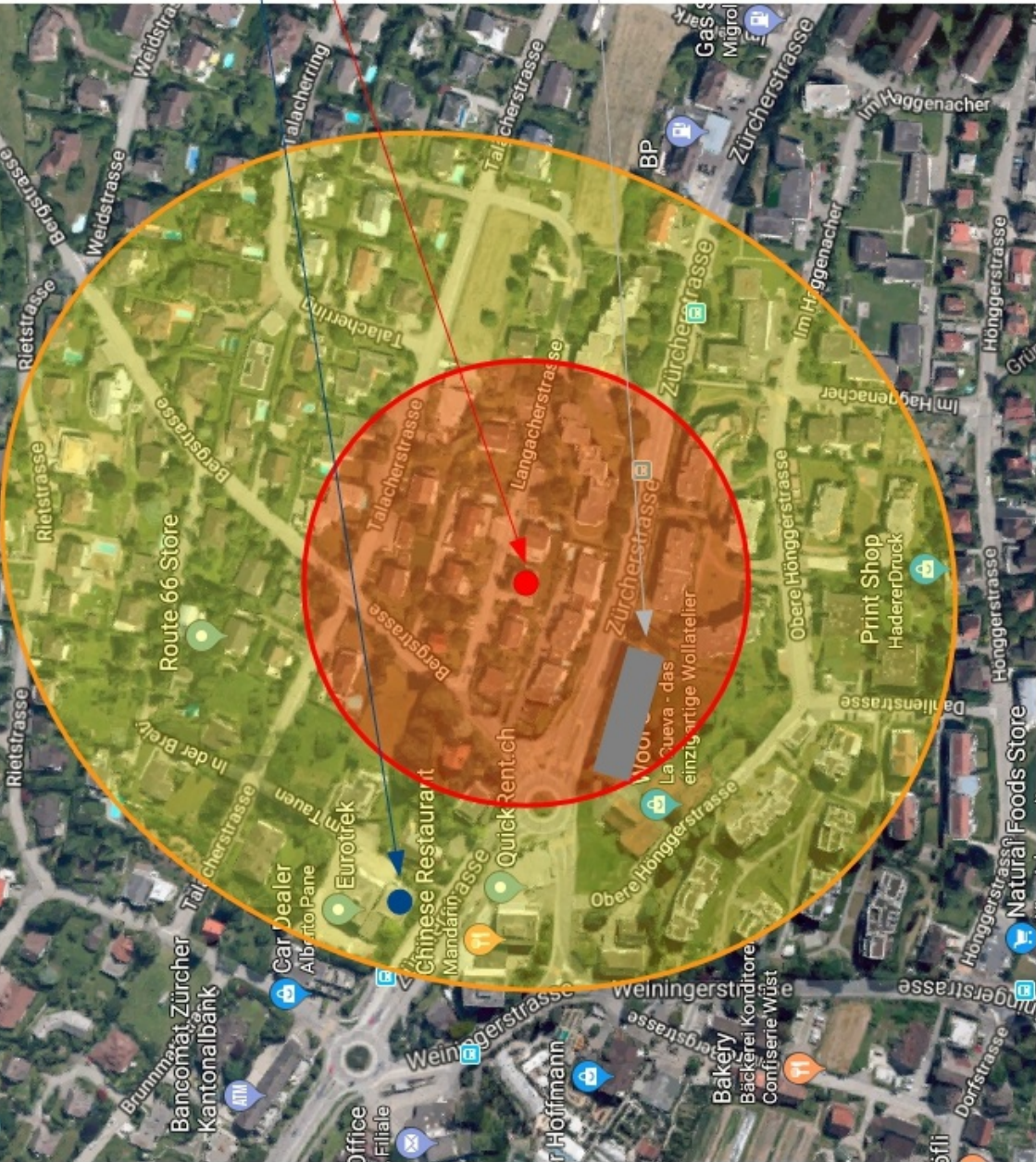

Missing on Map

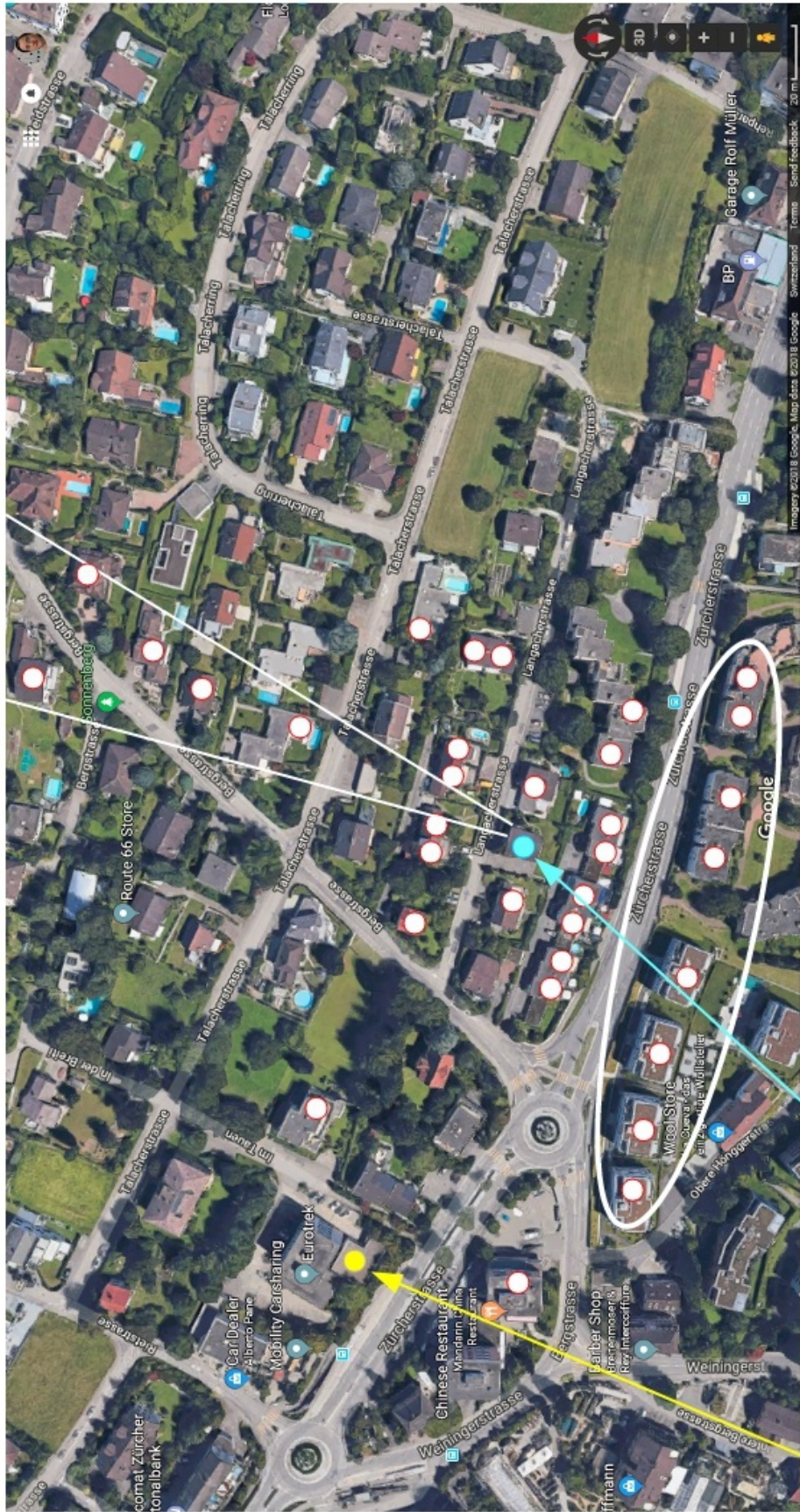
NOTE:

The Danger Zone is large as ~50% of the shots fired at the victim's home scatter off the walls and hit the neighbours. Attackers also typically target the surrounding homes.

The Danger Zone is asymmetric due to the hillside rising North of the victim's home.

Active Shooter Zone and Danger Zone in Unterengstringen around Langacherstrasse 6. The perpetrators often attack also surrounding neighbours.
