Since January 2016, I have been attacked with Directed Energy Weapons and have been tortured by the Body Area Network that has been non-consensually implanted in me in the UK at the University of Oxford by British Secret Services in the time period 2000-2012.

I have already requested a cease and desist in person in March 2017 in your headquarters in Bern. You refused to stop the attacks and have even demonstratively implanted a torture chip in my navel in June 2017. The attacks have steadily increased in severity to the extent that I am now being machine-gunned with Pulsed Energy Projectiles non-stop day and night in my own home, I am being mobbed by your surveillance networks when I leave the house, I am also physically shot at outside the home, I am also being tortured with targeted pain through my Body Area Network that is radio-controlled, and I am being raped several times per day by the Body Area Network implanted in my genitals.

I am an expert witness to the court cases of Siegfried Tomys in Biel, Switzerland, where he and his wife are assaulted by you just like I am. I am also an expert witness to the court case of Frederic Laroche in Grenoble, France, who is also being physically assaulted with Directed Energy Weapons and is tortured by his non-consensually implanted Body Area Network. The attacks on me have become so intense, painful and debilitating that I cannot undertake the necessary preparations for these court cases. I have now had to request that the court case of Frederic Laroche be shifted because of the attacks on me. You are perverting the course of justice with your physical attacks on me and with your targeted torture of my body with my Body Area Network.

I request that all terror attacks and the terror stalking is immediately stopped. I am making this request in preparation for the upcoming court cases, in which the NDB, Markus Seiler, Jean-Philippe Gaudin, the top leadership of the NDB and the top leadership of the military police is going to be charged with crimes against humanity, high treason, premeditated grievous bodily harm, and premeditated attempted murder.

I request that you cease and desist the attacks against me immediately. If you do not, the top leadership of the NDB will also be charged with premeditated murder.
