2 Dear Melanie, 3 Your case has been brought to my attention by a person concerned for your well-4 being. The issue that was flagged with me was that you appear to be still held imprisoned beyond your release date that was quoted to me to be 2nd June 2018. 5 6 I have followed your case for a while as one of the highest profile whistle-blowing 7 cases related to child abuse in the UK, which is also of international importance. The 8 Joint Investigation Team is currently preparing court cases against the Western 9 Secret Service for crimes against humanity, which include both human trafficking, 10 retaliation against whistle-blowers, and the corruption of the police and the judiciary. 11 Based on the facts that I am aware of, I am currently investigating your case under 12 the hypothesis that you have become the victim of a large-scale criminal conspiracy. 13 To be able to progress with the investigation and to be able to include facts related to 14 your case in the upcoming litigation, I kindly request that you grant me permission 15 to receive the information that I requested from HMP Styal, listed on the next page. 16 I kindly ask you to sign the release form, see next page, and return it to the prison. 17 After your release, which I hope to be very soon, please feel free to get in touch with me as I will endeavour to provide you with any assistance I can give. You can find 18 19 me and my team online. It is my goal to pursue your case without any further 20 inconvenience to you and most importantly without putting you at risk of any further retaliation. 21 22 Please let me also use this occasion to thank you for your service to humanity and 23 the children in the UK. Your work had a very large impact on opening long-due 24 criminal investigations into the most heinous crimes of our society. Thanks to your 25 courage to stand up to protect others and your extraordinary resilience in the face of 26 boundless criminality, we have now the largest international criminal investigations 27 in history looking into child abuse with waves of arrests already taking place. 28 With my highest regards,
