# **Explanatory Notes for the Affidavit Survey**

### **Abstract**

3 After an initial investigation of 2 years, Dr. Katherine Horton published a condensed  
affidavit template for the Joint Investigation Team for the purpose of an international  
survey of the victims of Secret Service criminality and State-led terror campaigns.  
6 The survey is intended to document the crimes against humanity revealed by the  
investigation and provide supporting evidence for the victims' court cases against the  
perpetrators. The 94-page affidavit template is based on the most common crimes  
9 suffered by reporting victims and codifies every aspect of the complex crimes into  
numbered lists of the typical forensic indicators. The template was first released in  
English but is suited to translations into other languages and the comparison of  
victim cases worldwide via the numerical code. The affidavit template is a public  
12 service for free use by victims and investigators, but its use requires full written  
attribution to its author Dr. Katherine Horton and the Joint Investigation Team US-  
Europe whose website can be found at: <https://jointinvestigation.org>

15 The affidavit survey is dedicated to Dr. Rauni-Leena Luukanen-Kilde, Dr. Paul

holocaust of the Secret Services, which underlies the crimes investigated by the  
survey. The launch of the survey on 11 November 2018, the 100-year anniversary of  
21 the Armistice was moved due to Directed Energy Weapons attacks on the author to  
17 November 2018, the 25th anniversary of the opening of the UN's first war crimes  
tribunals since the Nuremberg and Tokyo trials after World War 2. Lest We Forget.

# 1 Quick Guide for the Impatient

## General

- Only fill out those items you can testify about. Leave others blank.
- You don't need evidence for each item. Tick those where you have some.
- You do need to state everything under oath. Only testify to what is true.

## Text fields

- Free-text fields expand as you type. Don't go past the page, shorten text.

## Survey

- Use capital "X" instead of "x" in the survey so marks are clearly visible.
- State the start date of an offence as MM-YYYY, for example 08-2002.
- If items in the list have the same start date, save effort by *copy & paste*: (ctrl-a) (ctrl-c) then just repeat (↓) (ctrl-v) until the list is completed.
- Mark the frequency of ongoing issues as *Continuous* to *Monthly*.
- Mark number of distinct incidents in *Occurred Nx* (=N times) as "4" etc.
- Mark distinct events that occurred once with "1" or "X" in *Occurred Nx*.

## Perpetrators List

- Add new items in Section 83 with *right-click* → *Row* → *Insert*.
- Don't expand rows past the page. Keep perpetrators anonymous.

## Final Check

- Check & tick off each section in *Author's Cross-Check* (p.3-4 of affidavit).
- Before affidavit submission, complete the *Captain's Cross-Check* here.

## 2 The Background to the Survey

3 The Joint Investigation Team (JIT) began its work at the start of 2017. The founding  
investigators joined the JIT after several years of self-funded research into these  
crimes, necessitated by the fact that all of the investigators and their families have  
6 been personally affected by this criminality for several years. The investigators'  
personal experience with the methods, modern technology and covert weaponry  
used in these crimes includes non-consensual implanting with microchips and  
9 biosensors, neurotech assaults, non-stop torture, brutal mutilation, regular remote-  
controlled rape, countless death threats and repeated assassination attempts. As a  
result of their personal insights, the JIT investigators could analyse victim cases with  
a much more open and experienced approach than state-funded law enforcement.

12 While an in-depth analysis of these crimes has been beyond the capabilities and  
willingness of Western law enforcement, who have denied assistance to the victims  
and refused to investigate the crimes for several decades, the initial JIT investigation  
15 revealed large-scale international human trafficking, brutal and unfathomable crimes  
against humanity in every Western nation, and targeted torture of everyday families  
including young children and disabled people perpetrated by criminal networks in  
18 the Secret Services, law enforcement and the military with co-conspirators from  
every part of civil society. The JIT investigation also revealed brutal torture and  
murder in individualised concentration camps and public executions of victims.

21 The goal of the Joint Investigation Team is to document these crimes publicly, report  
the results of the investigation, and assist the victims in bringing the perpetrators to  
justice. More on the JIT can be found in Section 11.

## 24 3 The Purpose of the Survey

The purpose of the Joint Investigation Team's affidavit survey is to obtain written  
documentation of the crimes against humanity uncovered by the initial investigation  
27 and suffered by hundreds of thousands if not millions of victims around the world.  
The survey also aims to provide supporting evidence for offences that are very  
difficult to prove by individual victims but can be proven by a comparison of many  
30 cases and independent victim affidavits testifying about identical phenomena.

Attacks with Directed Energy Weapons (DEW) are a typical example of crimes that  
33 defy the classic methods of forensics as DEW shots can pass through several walls,  
injure or kill instantly without leaving a bullet hole, and lack other forensic markers  
that could trace back to the perpetrator. There is sufficient evidence to show that  
such murders and assassination attempts have indeed been committed precisely  
36 because the perpetrators could escape detection. Neurotech assaults are similarly  
hard to prove in many cases, but credible reports abound that make it clear that they  
occur much more frequently than even seasoned investigators would imagine.

39 With the systematic collection of witness and victim reports one can prove the use of  
these weapons to a standard that is sufficient for litigation. With high enough  
statistics, the crimes can also be traced back to the perpetrators for example in the  
42 Secret Services and the military in order to secure individual convictions.

Using affidavits from many independent victims, one can demonstrate that the large  
45 number of different offences within any given victim case cannot be the result of  
normal criminality. A Secret Service victim can suffer for example all of

3 housebreaking, car sabotage, computer hacking, Directed Energy Weapon assaults  
and financial sabotage. The forensic details of those crimes and their accumulated  
occurrence neither fit the typical cases nor the statistics of burglary, vandalism,  
6 cyber offences or white-collar crime respectively. In most cases the offences  
furthermore lack a motive outside Secret Service terrorism.

6 Once it is established that it is not normal crime, a judge can compare many victim  
cases from around the world, which tend to be surprisingly similar even if the  
victims have never met each other. This proves that large nation-wide and even  
9 international programs are at work, and leads straight to the perpetrators as there are  
very few networks that can be responsible for such coordinated attacks.

## 4 The Format of the Affidavit Template

12 The number and variety of crimes suffered by individual victims is so vast and the  
frequency of the offences so overwhelming that it goes far beyond anything that is  
currently known in standard police investigations. Therefore a condensed format had  
15 to be developed for the affidavits that allowed the recording of the crimes in a  
reasonable time frame with a manageable work load for victims. These requirements  
were particularly important to meet as most victims suffer ongoing mutilation and  
18 torture as they write their affidavits. Sophisticated assaults with neurotechnology  
that can severely impair victims and their cognitive endurance further necessitate a  
special format that takes into account circumstances which are truly unprecedented  
21 in the history of criminal investigations.

The JIT investigation also revealed that every country of the world is affected by  
these crimes against humanity. Therefore, a survey format was chosen that can be  
24 translated into any language and allows international comparisons of affidavits using  
the index number of offences since the Arabic numerals are universally understood.  
Affidavits thus serve as supporting evidence worldwide, which is crucial for the  
27 prosecution of the members of the global organised crime cartel behind the crimes.

For the reasons noted above, the affidavit template takes the form of a tick-box  
survey with the option to indicate the start date of each offence that makes up these  
30 complex crimes, the frequency with which a particular offence is suffered and the  
existence of evidence for each offence. Many items are extremely hard to prove for  
individual victims due to classification of the weapons used by the criminals and  
33 advanced high-tech deception which makes it impossible to collect appropriate  
evidence in many cases. The goal of the affidavit survey is to generate supporting  
evidence for each victim from a comparison of many victim cases so that the lack of  
36 evidence for a given offence is not a hindrance to bringing the perpetrators to justice.

**Victims should thus also report the offences that they do not have concrete  
proof for apart from their own experience. For the survey to be successful,  
39 it is furthermore important that victims are not cowed into silence by  
embarrassment, shame, fear of ridicule or fear of being smeared as delusional.**

### 4.1 The 8-Digit Authentication Code

42 The 8-digit document code chosen by the deponents and only known to them and  
JIT, allows them to check that their data has not been hacked or falsified and is used  
as authorised by the permissions granted on the first page of the affidavit template.

## 5 The Use of the Survey Results and the Template

### 5.1 Use of the Survey Results

3 The survey results can be used freely under the condition that special care is taken to  
uphold the rights of the victims and to respect and protect their dignity as the data in  
6 the affidavits are from real-life victims of crimes against humanity. No improper,  
demeaning, mocking, racist, misogynist displays or other uses that violate the human  
9 dignity of the victims or their rights are allowed. No commercial uses of the data are  
permitted such as the sale of the data. The data must also not be used for human  
experimentation or human subject research. Violations of these conditions can result  
in litigation by the author, the Joint Investigation Team or the victims.

### 5.2 Modifying the Template to Suit Other Uses

12 The affidavit template has been compiled and published as a public service to the  
international victim community. It is free to use by victims, help organisations and  
investigators worldwide and can be modified to suit individual purposes. The single  
15 condition for the modification and alternative use of the affidavit template is that the  
original author and her team are acknowledged in writing as follows:

18 This document is based on the affidavit template created by  
Dr. Katherine Horton for the *Joint Investigation Team US-Europe  
for Directed Energy Weapons, Military Neuro/Biotechnology and  
Systemic Corruption*. See the original template published in July  
21 2018 at <https://jointinvestigation.org>.

In case you would like to benefit from the affidavit results posted on the JIT website  
to support your own survey, it is advised that you do not change the item numbers  
24 from the ones that are listed in the survey. Add new categories at the section end.

**Please do not modify the version that you submit to the Joint Investigation  
Team from the original version that was published on its website.**

## 6 Authentication of the Deponents

27 The deponents have to submit photo identification alongside their affidavit. Serial  
numbers have to be blacked out to prevent the data being misused for identity fraud  
30 by hackers or saboteurs who are trying to undermine the effort of combining the  
insight from victims about their targeting to support victims in court.

## 7 The Funding of the Affidavit Survey

33 Dr. Horton's work was crowd-funded via donations by individual private donors. No  
corporations, charities, other organisations or large net-worth individuals are known  
36 by the author to have contributed. No demands or expectation of performance were  
placed on Dr. Horton through the donations. The resulting affidavit template and the  
survey are solely the work of Dr. Horton without any external influence or any  
financial, political, personal or other affiliations, ties or obligations to other parties.  
39 The donations were used by Dr. Horton to produce the affidavit template as a piece  
of work in the public interest in order to stop crimes against humanity.

## 8 Filling out the Affidavit Template Step-By-Step

### 8.1 The Title

The title identifies the affidavit as yours. You should write your full name, including middle names, ideally as your name appears on your identification document that you use to authenticate this document and your signature (passport, identity card, or in case you don't have any of these, your driver's licence). The title should appear without the yellow highlighting that was used to draw attention to the passage in the template. It should look similar to this:

### 8.2 Document Authentication

Choose a random 8-digit number that will be your personal document authentication code. Use numbers only (no letters or other characters), and avoid any number combinations related to you (like birthdays etc.) or combinations that show an obvious pattern like 11-11-11-11. The more “random” your choice the better as this number combination should only be known to you and the chance of someone else picking the same numbers should be small. For example:

It is important that you then **write the exact same number combination** that you have chosen on the left side of the footer at the bottom of the page (remove the yellow highlighting). The footer for the above example should look like this:

The document authentication code will be used to anonymise your affidavit while giving you control to check that it appears correctly, that it hasn't been hacked or modified, where it appears and how it is being used. The Joint Investigation Team will only use your affidavit as agreed in the *Permissions for Use* as outlined on the first page of the affidavit template. This includes publishing the anonymous public part of your affidavit online on the JIT website or in print to highlight the prevalence and horror of the crimes being committed against victims. Your name will not be connected to that anonymous public part of your affidavit. While the JIT endeavours to uphold your rights, it is important that you have the means to take action yourself against violations given the vast criminality being fought.

### 8.3 The Oath

3 The oath is in the form required by affidavits in the US and the UK. It confirms that  
you are saying the truth in a form that is recognised by the courts and is binding on  
6 you under penalty of perjury should you give false testimony. Write your full name  
as it appears on your ID papers (passport or identity card) used to authenticate the  
affidavit and make sure all the yellow highlighting and square brackets are removed.  
The passage should look like this, with your name and address inserted as shown:

9 “I, John Howard Doe, of 10 Park Street, London NW4 5GL, United Kingdom,  
state on oath and say as follows. I make this affidavit based on my personal  
knowledge, unless otherwise stated, and that the following facts and matters are  
accurate to the best of my knowledge.”

12 The oath has a second part at the end of the affidavit called the *Statement of Truth*  
which has to be signed in the presence of a person entitled to administer oaths, see  
Section 8.23.

15 Through the oath, the *Statement of Truth* and your witnessed signature, the affidavit  
becomes a legal document that has significant power in a court of law. The oath is  
also intended to separate assets of the Secret Services and hired crisis actors posing  
18 as fake victims from real victims. Through signing the document under oath a fake  
victim would commit perjury and be perverting the course of justice. They can thus  
be taken to court for such actions.

21 Meanwhile, if you are a real victim you should not fear submitting under oath the  
crimes and torture that you have suffered. It is important that you stick to those  
offences that you have suffered, have witnessed or that have been committed against  
24 you without your knowledge at the time, but where you have reasonable grounds to  
believe that they were the result of criminal actions.

27 You should also not be shy to submit those crimes that are hard to prove, for  
example manipulation with *Synthetic Telepathy* or physical pain and suffering as a  
result of *Remote Neural Monitoring* or Directed Energy Weapon attacks. The entire  
point of the affidavit survey is to combine the testimony from many independent  
30 victims to show that these covert crimes using advanced technology are being  
committed on a large scale.

### 8.4 Permissions for Use

33 The text states the purpose of the affidavit and how it is intended to be used. It draws  
attention to the origin of the template and to the glossary of the terms used within  
the affidavit. The glossary is in this document and describes the meaning of the  
36 special terms used in the survey. This is important as all people who submit an  
affidavit have to mean the same type of incident under the terms listed in the survey,  
for example under *gang-stalking* or much more technical expressions like *Synthetic*  
39 *Telepathy* or *Remote Neural Monitoring*.

42 The Joint Investigation Team intends these affidavits to be used for an analysis of  
the crimes being committed against victims and as supporting witness or victim  
affidavits to be used in the court cases of Dr. Katherine Horton. The JIT and  
Dr. Katherine Horton will never publish the names of the individuals who submit an  
affidavit, or connect their personal details to the facts testified about in the affidavit.



## 8.5 Private and Public Parts of the Affidavit

To protect your privacy, the survey is split into private sections at the start and at the end, and a public section in the middle that contains the anonymous tick-box survey and the public list of perpetrators on pages 2–93.

The private sections confirm your identity with your name, address, your photo and your signature to avoid crude falsification of the survey results by fraudulent victim identities planted by Secret Services. Court cases in Europe and the US require that the identity of the person providing an affidavit is known and in European countries identification documents have to be provided along with the affidavit.

For this reason, the first and the last page of your affidavit as well as your ID documents are not published but are used to authenticate you. The public part of the affidavit is the middle section, which is clearly marked and completely anonymous. The public part of affidavit submitted to the JIT will be published on the JIT website for free download by other victims and investigators to study the crimes and as supporting evidence for individual victim cases around the world.

By returning the affidavit to the JIT you grant implicit permission to publish the public part on the JIT website and in print. Therefore, nothing in the public part of the affidavit should be used to identify you.

**Please make sure that the perpetrator list at the end of the affidavit is anonymous and does not state names that can be used to identify you.**

Once the private parts have been stripped from your file, only the 8-digit document code chosen by you in the footer of the public part of the affidavit identifies your affidavit. The 8-digit code is only known to you and the Joint Investigation Team. The purpose of this code is specifically so that you can recognise your affidavit on the JIT website and check that what has been published agrees with the original submission and no hacker has interfered with the final document.

## 8.6 Identity Confirmation (Not for Publication)

For the reasons stated in Section 8.5 above, the survey has to be submitted with a valid photo identification document, such as a passport, ID card, or driver's licence should you neither have a passport nor an ID card. The identity documentation and the private parts of the affidavit are **strictly not for publication**.

While the JIT needs to confirm your identity to show that the affidavit is from a real person, it does not want to assemble a database of passports or identity cards that could be hacked and used for identity fraud to harm the victims.

In order to prevent that the copy of your ID document is misused by hacking of the JIT accounts, you have to cover up or black out the serial number of your passport or ID card in the submitted copy so that no identity fraud can be committed with it. Take special care as it might appear several times on the document.

**Please blank out the serial number of your passport or ID!**

The information you provide on the first page of the affidavit, namely your photograph, name and address have to match the information on your passport or ID card. The photo does not have to be the same image as on the ID documents, but it has to be a passport-grade true likeness of you.

The photo is to identify the affidavit as yours, so that in case of doubt it can be checked against your passport information

3                    **Delete the text in the box before dragging and dropping your digital photo into the box so that the size of the box is preserved.**

6                    If the box messes up the formatting or stretches outside the page, please resize it so that it fits on the first page again.

## 8.7 Summary Overview & Author's Cross-Check

9                    The first two pages of the public part of the affidavit, pages 2-3, are the summary of the entire document. They give users like other victims, police and judges a quick overview of what type of criminality is reported by a given victim and compare many affidavits with ease. Skip the *Author's Cross-Check* for now. It's explained late in Section 8.20.

12                    **Skip this section for now and fill it out last once you have completed the entire document!**

## 15                    8.8 Personal Information

18                    The information regarding sex, age, disability etc. is only used to investigate if certain types of victims are singled out by the Secret Services and their criminal networks. One line of investigation is for example weather it is predominantly women, foreigners and disabled people being targeted.

21                    You don't have to provide your precise age, as that might be used to identify you. Write "40s" if your age is between 40 and 49, "50s" if it is between 50 and 59 etc.

24                    **Mark the tick-boxes with X (upper case) instead of x (lower case).**

27                    The country information helps to prove which Secret Services are committing crimes against humanity and since when. The list of victims that are affected in your family and community reveal how extensive the targeting programs are.

30                    The field *Targeted in These Countries (List)* automatically expands as you type. So you can list as many countries as apply.

## 33                    8.9 Classical Crime

36                    Please note that the list of *Classical Crime* means strictly those incidents that have a clear criminal or opportunistic element that would be attributable to standard crime as it is commonly known. This is to assess how many victims are affected by known types of crime in addition to atypical crimes.

39                    Please exclude from this list inexplicable, highly exotic or bizarre offences that for example aim to cause only psychological trauma or have the hall-mark of the abuse of advanced technologies and human experimentation.

42                    Examples of atypical crimes that should not be included in this list are for example burglaries without theft of valuables for gas-lighting or terror purposes only, and kidnap for purpose of implanting or kidnap in the style of alien abductions. These are included in later sections but should be left out here.

## 8.10 The Tick-Box Survey

The central 90 pages of the survey collect information on the different types of offences suffered by victims by recording the start of a given violation, its frequency and if there is evidence to corroborate it.

The average victim suffers an extremely large number of different offences that are not related to each other within classical crime and that occur in victim cases much more frequently than would be typical for the given type of crime. It thus follows that something other than standard criminality is responsible for the offences. Only a national secret service with reach into the police is capable of orchestrating the types of offences suffered by victims with impunity.

The choice of which types of offences and what details about them to include in the survey is based on 1.5 years of intense investigation, the statements of reporting victims who contacted the author, as well as the author's own experience as a victim.

Any selection is bound to be incomplete. Therefore, to avoid the omission of important offences, you can name up to 29 additional offences in Section 71.

**Only fill out those items you can testify about. Leave others blank.**  
**Not testifying about an offence does not bias any future litigation.**

The offences related to targeting are numerous. Therefore, the affidavit template uses the form of a tick-box survey with every category of crime split into its forensic indicators and typical offences. Indicate the first occurrence of a given offence in the column "Start (M-Y)", for the starting month and year of the offence in the format MM-YYYY, for example 06-2009, as shown below. If the precise month in which a certain offence first occurred is not known please just indicate the year.

In the subsequent columns mark how often a given offence has occurred. Choose from *Continuous* / *Hourly* / *Daily* / *Weekly* / *Monthly* or if an offence has occurred only a set number of times indicate how often in the column *Occurred Nx* (occurred N-times). For example, write 3 for three occurrences of a given offence. If an offence occurred only once you can mark it with "1" or "X".

In the final column indicate if you have any evidence for that type of offence, see the next section for what is considered valid evidence.

**Mark also offences for which you do not have evidence.**

**NOTE:** Items sometimes contain two or more options. These can be separated by *and* and sometimes by *or*. Please treat *and* and *or* as if they were the same. Note down if you are affected regardless if both of the options apply or only one.

### 8.11 What Constitutes Valid or Admissible Evidence?

Evidence can be in the form of photos, videos, audio recordings, screenshots, samples, documents, notes, witness testimonies, measurements, official documents, printouts, news reports, patents, laboratory tests, medical imaging and many other types of forensic evidence.

Indirect or circumstantial evidence can also be important. The mere fact that you tried to collect evidence can also be evidence that there were violations against you. For example, if you made a video 4 years ago trying to film a gang-stalker and you described what the stalker did on the video recording, it would still be good evidence even if the stalker had disappeared by the time you got your camera out. That's because you can use that evidence to prove that already 4 years ago you were collecting evidence of gang-stalking terror against you. This would show that you have been the victim of continued harassment campaigns going back to that time.

It should be emphasised once more that you do not need evidence for every offence you testify about. That is because the entire purpose of the affidavit survey is to prove crimes that are hard to collect evidence for or are maybe impossible to prove.

### 8.12 Important Violations not Mentioned in the Template

Section 71 on p.82 of the affidavit template, called *Other Issues of Importance (Chosen by the Author)*, allows you to list crimes and violations that you have suffered that you cannot accommodate anywhere else in the affidavit. You can name up to 29 additional items that you consider to be important.

Please make sure to check the entire affidavit before listing offences that can be found elsewhere or could be accommodated in other sections. That is because the power of your affidavit lies in corroborating offences together with other victims, while the offences stated in this Section 71 would be different for every victim.

Section 71 is best used for fundamentally different offences, important aspects that were omitted by the author, or violations that were particularly grave or significant in your targeting. Victims seem to be placed in different human experimentation programs or are at the mercy of different criminal business schemes, therefore there can be certain types of offences that the author is not aware of but that nonetheless affect a large number of people. Curious, rare or unusual offences might also help to reveal the goal of criminal schemes or high-level perpetrators behind the crimes.

### 8.13 Threats and Retaliation for Writing the Affidavit

Unfortunately, it is very common that victims are retaliated against by the Secret Services and their criminal networks for taking legal steps against these crimes. In order to discourage such retaliation and, should it occur, to be able to note it as malicious attempts to pervert the course of justice, Section 72 on page 80 allows to note down any adverse incidents suffered in direct correlation with the writing of the affidavit. Please also include attacks on your family, friends, pets and others.

## 8.14 Warfare Operations

3 Section 73 on page 80 is listing the types of covert warfare waged against victims  
around the world. Please mark all the warfare methods that have been used against  
you, your family, friends, members of your community and your pets.

6 The purpose of this is to show judges how all-encompassing and overwhelming the  
covert warfare operations are, and how many different types of expertise are  
involved in conducting such large-scale operations internationally.

## 8.15 Violations of Rights

9 In Sections 74-77 you can list how many of your human rights have been violated by  
the Secret Services and their criminal networks. Section 76 refers specifically to the  
European Convention on Human Rights. This is because they are of particular  
12 significance within Europe.

15 However, as the European Human Rights Convention aims to reflect a universal  
standard of protection that has to be afforded to all people worldwide, you should fill  
out this section even if your targeting took place outside Europe, and you are neither  
a national nor a resident of Europe.

18 That is because the companies involved in your targeting might very well be  
European and they have to be taken to court for violating the rights of people outside  
their jurisdiction in a manner that would be highly criminal within Europe. It also  
helps to compare international victim cases with those in Europe.

## 8.16 Denial of Help and Self-Help

21 One of the most devastating aspects of Secret Service criminality is that their reach  
into all institutions and communities is being weaponised to deny victims any form  
24 of societal support. Most victims are refused the most basic assistance, which they  
are entitled to according to the statutory duties of the state, and are denied help by  
every section of society. As a result, the victims continue to suffer systematic torture,  
27 mutilation and murder that a large section of society acquiesces to, maliciously  
condones or actively takes part in. This aggravates the war crimes and crimes  
against humanity that the Secret Services are committing.

30 Section 78 aims to highlight this aspect and the desperation into which the victims  
are pushed by the Secret Service criminality. For many, it is this total isolation from  
any form of help that pushes them towards suicide.

33 This Section also aims to show that in order to be able to protect themselves and  
shut down this criminality, victims would have to recapture every institution from  
organised crime or form their own institutions replacing the police, medical care, the  
36 press, the military and the judiciary.

39 Section 79 is the counter-part where you can indicate how much work you have to  
invest into self-help and helping other victims under a denial of service from police,  
counter-terrorism units, doctors, charities, the press and governmental institutions.  
The fact that you are forced to do the work of all these people while paying taxes for  
precisely such services to be rendered and duties to be fulfilled shows the extent of  
42 rampant criminality and the mismanagement of public funds.

## 8.17 Costs

Victim reports and the personal experience of the investigators show that the financial damages incurred by the boundless criminality are staggering. In many cases, becoming the victim of these crimes against humanity leads to total financial destruction, which is clearly intended.

This section aims to quantify the damages incurred by victims and the costs of shielding and counter-measures. Loss in earnings and extra expenses for example from forced house moves are also part of the financial damages resulting from targeting.

Round up to the nearest unit of the currency that you are quoting the sums in, so that you write whole numbers without a decimal point – that is what is referred to as integer sums in the section title. Integers are the whole numbers like 1, 2, 3, 43, 342 as opposed to decimal numbers like 1.34, 2.57.

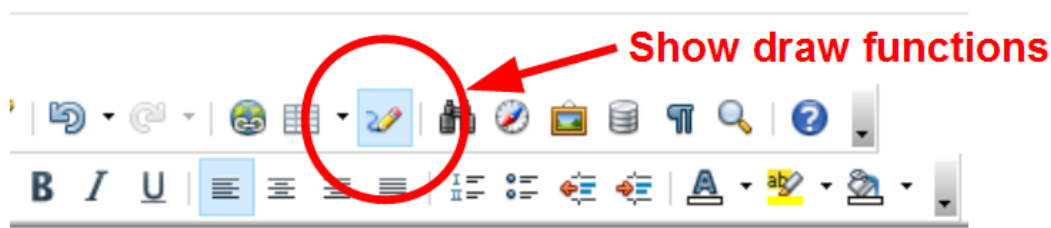
## 8.18 Body Diagrams

This section aims to shed further light on criminal human experimentation and targeted mutilation and murder programs. The diagrams visualise targeted assaults to vital organs, what type of bio-robotisation the criminal networks have implemented in the general population and if there are differences between the torture and bio-robotisation of men and women.

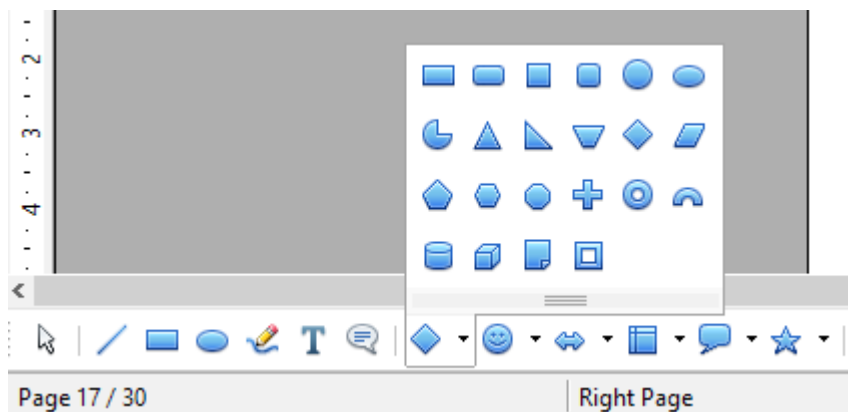
For this purpose, the male and female body diagrams allow to show the body areas that are typically assaulted and the location of non-consensual body implants, if the latter is known. Use the male or female body diagram, as appropriate for your case. The first set in Section 81 asks for the *Most Common Attack, Pain and Injury Locations*, whereas the set in Section 82 enquires about *RFID Sniper-Shots* and *Chip Implant Locations (If Known)*.

Please note that while the while title reads *Chip Implant Locations*, all types of body implants are meant to be included not just microchips, for example also nanotech networks without radio-frequency emitting chips in the area. In other words, the section ought to read *Chip/Other Implant Locations*. RFID Sniper-Shots, which also appear in the section title, are a method to implant chips and nanotech. If you have ever been shot with an RFID rifle, you know what that feels like.

In order to fill out this section, please activate the *OpenOffice* drawing tools by clicking on the pencil icon show below.

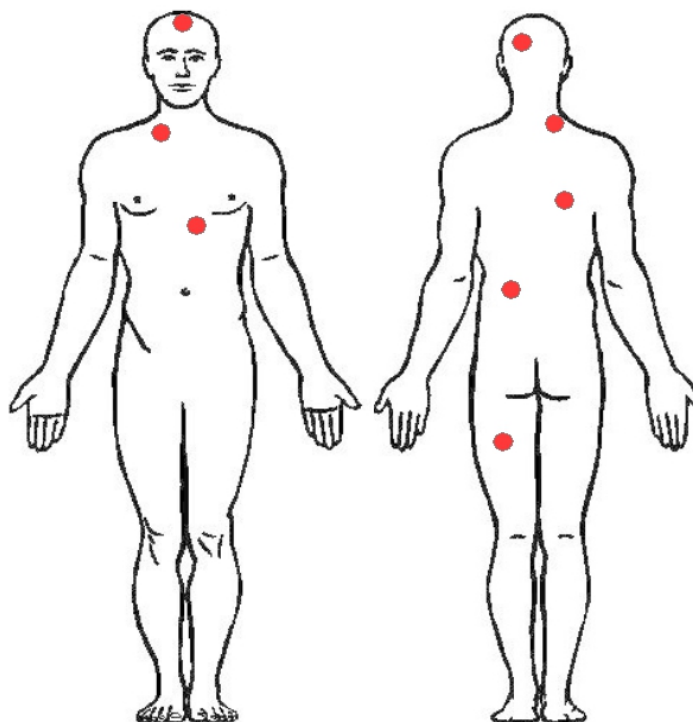


Use the drawing tools that appear at the bottom left of the *OpenOffice* document to select for example a circle that you can use to highlight the areas of the body where implants are located or attacks are targeted at.



3 You can set the colour of the circle using the top bar. Select the fill colour to be red to make your markings clearly visible on the body diagram. Also make the circles small enough to distinguish the regions of the body they are intended to highlight.

The resultant body diagram might then look akin to the images below. In a real-life victim case there might be many more red markers depending on the case.



6 **8.19 List of Perpetrators**

9 The main goal of the affidavit is to identify the criminals and bring them to justice. However, the resources of the Joint Investigation Team are so limited that it is impossible for Dr. Katherine Horton to do the work of worldwide police services.

12 Therefore, Dr. Horton cannot handle detailed lists of personally named perpetrators collected from around the world. Libel lawsuits as targeted take-down operations by the perpetrators and the Secret Services also have to be avoided.

3 For these reasons, the list of perpetrators has to be kept anonymous. What should be testified about is the type of individuals involved in the abuse, for example neighbours, family members, police officers, County judges and Air Force officers.

6 The accusation, charging and prosecution of the perpetrators is your responsibility as the victim of the crimes and your lawyers. The Joint Investigation Team cannot take on that responsibility with the manpower and funding it currently has.

9 Nevertheless, Section 86 is dedicated to the public outing of all those members of the criminal networks who have been involved in your abuse. These can be people from every part of society from the highest levels of government office or corporate leadership to the local neighbourhood.

12 Do not be shy to list every person whom you have strong grounds to believe to have taken part in your abuse or facilitated your abuse knowingly. Just make sure that you do not give their name but instead describe their function or their relationship to you and on what grounds of evidence you accuse them.

15 You can name individuals in government, Heads of State, military leadership, and Chiefs of Intelligence Services as the information does not identify you further than the country the offences have been committed in. However, avoid naming individual cities and people in your local area like the members of your Town Council as that can be used to identify you.

For example, your perpetrator list could name individuals as follows:

- 21 1. *The Chief of Domestic Intelligence of Germany, due to the fact that large-scale domestic terror campaigns have been reported to his office repeatedly over several years without any investigation or stopping of the terrorist acts.*
- 24 2. *The Chief of Police of a large French city, as I can testify to the fact that several victim cases have been submitted to him and there was not a single investigation nor any follow up of any of the cases.*
- 27 3. *The director of a city hospital in Texas where I was abused and implanted. Medical scans have shown implants in the area where I had surgery in that hospital. I have also seen evidence that other victims have been implanted there and also have been openly abused like me. It thus appears to be based on a systematic business plan that must be sanctioned by the director.*
- 30 4. *The surgeon of the city hospital in Texas, named above, who conducted the surgery on me where subsequent medical scans showed implants in the area.*
- 33 5. *My cousin, who has openly engaged in slander campaigns against me, tried to cheat me out of my inheritance and has used gas-lighting techniques on most of our family unions, trying to disconcert me in a malicious manner.*
- 36 6. *Five neighbours around my home and two neighbours adjacent to my elderly parents' home who appear to be involved in targeting Directed Energy Weapons at us in our properties.*
- 39 7. *Four colleagues at work who have taken part in gang-stalking and street theatre terror against me.*
- 42 8. *Countless unidentifiable gang-stalkers who are swarming around me every time I leave the house and also follow me in cars, into shops and doctors' surgeries trying to violate my privacy in every way imaginable.*



## 8.20 Check the Affidavit using the *Author's Cross-Check*

When you have finished filling out the entire affidavit template, please print it off to check it in hard-copy. It is important not to do the final checks on the computer as the brain processes information on a screen differently to something that appears on paper. Many mistakes that have eluded your attention looking at the affidavit on your computer should be noticed once they appear on the hard-copy in front of you.

It is easiest to do check your document by keeping the printout of the affidavit next to you as you are marking each section in the *Author's Cross-Check* on the computer.

### **Go through your entire affidavit twice.**

On the first round, look at every section of your affidavit and mark the relevant section under the column *Affected* on pages 3-4 as soon as a single item of that section was marked in the main part of the affidavit.

For example, you can immediately mark Section 1 *Targeting in General* in the *Author's Cross-Check* since you are a victim and will have entered something in the that Section. Then mark Section 2 *Classical Crime* as soon as you have placed an "X" in any of the *Yes* fields. Similarly, mark any of Sections 3 *Intrusive Surveillance* to 8 *Housebreaking* if you have place a single "X" in any of the respective sections.

Please note that *Affected* changes to *Completed* on the third page of the *Author's Cross-Check*. That is simply because it is more apt to use *Completed* instead of *Affected* for those items. It has no other significance.

After you have marked every section that applies to you, go through the affidavit a **second time**. This time, go very slowly item by item, making sure that

- you have marked the right offences,
- the frequency is marked correctly (hourly, daily etc.),
- the start of the offence is correct (month-year in the format MM-YYYY),
- you have indicated correctly if you have evidence for the offence.

Once you are sure that you have filled out each row of a section correctly, mark the section as *Checked* in the *Author's Cross-Check*. Remember that you are testifying to a court with this affidavit so take great care that what you are writing is the truth.

**Your completed affidavit should have both fields *Affected* and *Checked* marked for every section that applies. Makes sure that this is the case to show that you have taken great care to ensure that your affidavit is correct and true.**

## 8.21 Check the Spelling of Your Free Text

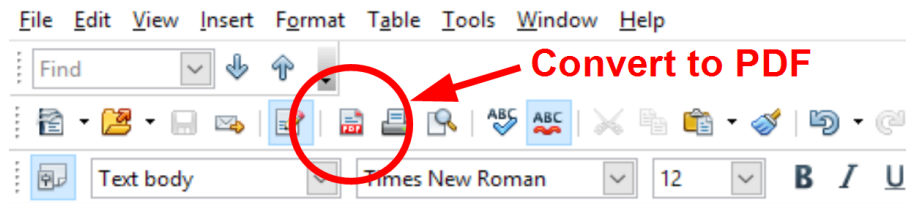
After completing the affidavit template as described above, please run a spell-checker over the free-text passages that you have written in the list of perpetrators on page 92 and in the list of countries on page 5.

**Do not modify any of the fields that came with the original template even if your spell-checker highlights them as misspelled.**

It is possible that your *OpenOffice* spell-checker flags the British English spelling of some term in the template if you are using American English. Please leave it as it is.

## 8.22 Convert the *OpenOffice* Document Into PDF

- 3 After completing the steps described above, please convert your document into the PDF file format by pressing the *Convert to PDF* button in the task bar at the top of your document, as shown below, or selecting *File* → *Export to PDF* in the task bar.



- 6 It is important that you convert the *OpenOffice* file into a PDF because then it cannot be modified by accident and the file will appear exactly as you saved it across all operating systems *Windows*, *Mac* and *Linux*.

## 9 8.23 Statement of Truth

- 12 Signing the *Statement of Truth* before a person entitled to administer oaths, for example a notary public, a licensed solicitor or an Officer of the Court, turns your affidavit into a valid court document that can be used in jurisdictions worldwide.

**Only sign it before the person entitled to administer oaths, and not beforehand!**  
**Also show your passport or ID card to the witness before signing.**

- 15 You can fill out the third line where your name has to be printed on the computer. Then print off the document and take it to a person who is authorised to administer oaths. Date and sign the document before that witness. This certifies that the signature is indeed yours and that you are testifying to the truthfulness of the content in person, in sound mind and not under duress. You will have to show your passport, ID card or driver's licence. The bottom half of the page is to be filled out by the witness. They will know what to do.

- 24 It should be noted that both a notary public and a commissioner of oaths can administer the oath. The affidavit only requires a person entitled to administer oaths who does not have to be a notary public.

**Full notarisatation is not required for the purposes of the affidavit survey.**

- 27 Full notarisatation is a lot more expensive and is only necessary if the content of the document would need to be legally executed, which is not the case here.

- 30 In Europe, witnessing a signature by a person entitled to administer oaths costs around EUR 10, whereas full notarisatation by a notary public can cost over EUR 80. While a notary public can witness your signature, make clear that that is the service you require and not full notarisatation so that you do not incur the higher charge.

## 8.24 Scan the Last Page and Do the *Captain's Cross-Check*

- 33 After the witnessing, scan the page with the signatures. Save it as a PDF document. You do not have to scan the entire affidavit as the other pages are already in a PDF format. The *Captain's Cross-Check* below explains how to send it to the JIT.

## 9 The Final Captain's Cross-Check

### To Do Before Submitting the Affidavit to the JIT

- You have spent enough time on each section and did not neglect latter sections.
- Author's Cross-Check*: relevant items are marked both *Affected* and *Checked*.
- A passport-quality photograph of yourself is included on affidavit page 1.
- You have run the spell-checker on the free-text sections & corrected mistakes.
- The affidavit is converted into a PDF (PDF symbol top left, or *File* → *Export as PDF*).
- You printed off the document including the *Statement of Truth* for certification.
- Signed the *Statement of Truth* before a person entitled to administer oaths.**
- You scanned the signed & witnessed *Statement of Truth*. It's now in a PDF file.
- You scanned your passport/ID card with the serial number covered up.**
- You prepared an email to the JIT using exactly the following text:
  1. you entered the subject of the email as “**Affidavit for JIT Victim Survey**”,
  2. you wrote “Please find attached my affidavit that I submit to the JIT survey.”
  3. you attached the PDF of your full affidavit (all 94 pages) to the email,
  4. you attached the PDF of the scan of the witnessed *Statement of Truth*,
  5. you attached the scan of your passport/ID card without the serial number.
- You sent the email to **all of the following Joint Investigation Team inboxes:**

The reason the JIT use 4 emails is to circumvent the sabotage of any one email account by automatically backing up the affidavits four times in separate accounts that are maintained separately. The *Protonmail* account resides on servers in Switzerland and has the added privacy feature of being encrypted such that not even the *Protonmail* IT staff can access the content of the emails (see <https://protonmail.com>). While that provides a much higher privacy guarantee than Gmail, it comes with the disadvantage that in the case of a hacker gaining access and changing the password, the account becomes irrecoverable and has to be deleted since *Protonmail* IT staff cannot access the data. For this reason, Gmail accounts have been selected as a backup. Victims worried about privacy should consider that in any case every email sent over the internet anywhere in the world is intercepted and stored by the NSA.

## 10 Acknowledgements

3 Several people assisted in the finalisation of the affidavit template by going through  
the template with a fine comb, adding valuable points to the list of offences,  
inspiring the author to add or rewrite entire sections and helping to polish the final  
6 version. In particular, the author would like to thank two people, who shall remain  
anonymous, for going through the document in detail and providing several pages of  
7 thoughtful comments and suggestions, which were incorporated into the affidavit  
template and added several items to the list. Lucy B. submitted several pages of  
9 insightful points and questions that helped to develop the FAQ in this document. The  
author also thanks Jeff H. for proof reading the entire document and spotting scores  
12 of errors and slip-ups, Karen Melton-Stewart for combing through the final version,

24 Last but certainly not least, the author would like to thank the host family who gave  
her refuge in Hungary for 6 weeks when she had to flee her home in Zurich due to  
the brutal retaliatory attacks by European Secret Services MI6, BND and NDB. The  
27 lady of the house provided not just a roof over the author's head, health-restoring  
sustenance, pain-killers to cope with the brutal attacks from Hungarian Secret  
Services who were hired to continue the assaults, but also words of wisdom and  
30 encouragement that helped the author get through this extremely difficult time. It is  
thanks to her and the loving care of the rest of the host family that the author did not  
just survive the attacks to complete the affidavit template, but also emerged from the  
33 experience with even more love for humanity after having experienced a group of  
people who are truly precious jewels in this world.

36 Thank you all for your contribution, encouragement, and unwavering support.  
Without your help the author would not have had the determination to finish the  
document under the non-stop physical assaults, and it would not be what it is now.

39 May this affidavit template help many people around the world in the years to come  
and may it assist in putting to rest an ancient system of torture, enslavement and  
covert murder of the most heinous kind.

## 11 The Joint Investigation Team

3 The Joint Investigation Team was founded by Dr. Katherine Horton in early 2017 to  
investigate horrific crimes against humanity committed by Western Secret Services  
and the military with the use of Directed Energy Weapons, covert neuro- and  
biotechnology and the systemic corruption that underlies the spread of these crimes.

6 The Joint Investigation Team is a US-European collaboration between high-integrity

## 13 Appendix 1 – FAQ

### 13.1 Can I fill it out on paper and then post it?

3 No, unfortunately you cannot. Please fill it out on a computer. Paper copies cannot  
be accepted because the processing and storage of 94 pages for each affidavit  
exceeds the capacity of the JIT.

6 Note that while the affidavit has to be filled out electronically. The last page has to  
be printed, signed before a person entitled to administer oaths, scanned with both  
signatures and emailed to the JIT along with the completed survey and a copy of  
9 your identity card or passport. All documents have to be in the PDF format.

### 13.2 I cannot fill it out electronically. What to do?

12 The JIT is aware that there are victims who do not have a computer or are  
uncomfortable using computers. Victims are encouraged to reach out to each other  
and provide mutual assistance to give those, who don't have a computer or internet,  
access to the necessary facilities. At the end of the day, the global crime cartel that  
15 we are fighting can only be shut down if we all learn to support each other.

The purpose of the affidavit survey is to establish publicly that these crimes are  
indeed happening. If individual victims cannot take part in that phase because they  
18 cannot use a computer, then they will still benefit from the publication of the short-  
affidavits of other victims.

### 13.3 Can I change the affidavit template or add items?

21 No, you cannot change the affidavit templates if you submit it to the JIT. However,  
Section 71 entitled *Other Issues of Importance (Chosen by the Author)* allows you to  
add up to 29 items of your own choosing.

24 The aim of the JIT is to compare many victim affidavits to prove in court that  
systematic programs are being conducted around the world and to prove the core  
aspects of the criminality or those programs. For that purpose it is important to focus  
27 on those aspects that are common to most victims and to ensure that all victims  
report the offences in the same form.

Section 71 is intended to collect offences that have been left out or are significant for  
30 the victim or are of forensic importance for the investigation of the perpetrators.

Furthermore, you are welcome to use the affidavit template to launch your own  
victim survey. Then you can change the template freely and adopt it for your use.  
33 But please make sure that what is submitted to the JIT uses the original template.

### 13.4 What to do with sections or items that do not apply?

36 “Many sections do not apply to me, do I have to strike them out? And can I still use  
the affidavit template if most items are of no relevance to my case?”

Yes, you can still use the affidavit if sections or even large parts do not apply to you.  
Simply fill out the sections that are relevant to you. But please leave the other items  
39 blank and as they appear. Do not delete or strike out any items or boxes.

### 13.5 Why isn't there “No”, “Not Sure” or “Don't Know”?

3 “Why is there no box for No / Not Sure / Don't Know? Aren't you afraid that if left  
blank anyone could hack & add info?”

6 The reason there is no box for “Not Sure”, “Don't Know” is because the purpose of  
the affidavit survey is to collect those aspects that the victims are sure about and can  
attest to with confidence or have reasonable grounds to conclude. If an item does not  
apply to you or your are unsure please leave it blank.

9 The affidavit survey avoids tick-boxes for “No” in order not to bias future court  
cases of victims. It focuses only on the aspects that definitely occurred. That's  
because these high-tech crimes are extremely complex and victims are overloaded  
on purpose by the perpetrators. As a result, many aspects of the crimes only become  
12 clear with time, or are remembered at a later stage. Certain types of attacks are only  
recognised after comparison with similar cases.

### 13.6 Where can I record offences not listed in the survey?

15 In Section 71 entitled *Other Issues of Importance (Chosen by the Author)* you can  
add your own items that are important for your case or are of forensic importance.

### 13.7 Not sure if the sensations I have are due to implants.

18 Only enter information that you are sure about. The section on implants is for those  
who have identified implants themselves, for example from a recurring sensation  
they can pinpoint, from an implant that is palpable, or from measurements of radio-  
21 frequency emissions. Some also have X-rays and other medical evidence for their  
implants. If you have none of these and are unsure simply enter what you have  
witnessed in the section entitled *Physical Signs & Symptoms*.

### 24 13.8 I'm not comfortable filling out a section. Do I have to?

27 Absolutely not. You don't have to fill out any section that you are not comfortable  
with and you don't have to give any information that you do not want to give.  
Simply leave the item or the section blank. But please do not delete any items.

30 If you leave sections blank you can still submit the affidavit. Blank rows are simply  
ignored and no implicit assumptions are made about those items, it is simply logged  
as “no information given”.

### 13.9 How can I be sure that no one hacked or added info?

33 You are strongly urged to keep a copy of your submitted affidavit in a secure place  
and backed up. The JIT is going to publish the public part of each affidavit on the  
JIT website at <https://jointinvestigation.org> so that you can check that what appears  
36 on the website is what you have submitted. You can find your own affidavit using  
the document authentication code that you have chosen yourself, which appears in  
the footer of the affidavit. If there are any discrepancies between your copy and the  
published version, please get in touch with the JIT.

39 Hacking of victim affidavits is a case of perverting the course of justice and thus an  
actionable offence. Such instances can be prosecuted in court.

### **13.10 I am scared of retaliation for writing this affidavit.**

3 Note down any retaliation you suffered for completing the affidavit in Section 72 on  
page 80. If you are scared of even harder retaliation upon submitting your affidavit  
6 to the JIT, contact someone you trust, or ideally 3 people you trust, and tell them that  
you are submitting this affidavit. Leave back-up copies with them, and leave copies  
of important evidence with them and ask them to contact the Joint Investigation  
Team should something happen to you.

9 If you reported publicly about the assaults on you on Twitter, then you can also  
download your Twitter archive from within your Twitter account and email that  
archive as evidence to your trusted network or burn your Twitter archive onto a CD  
and give it to them for safe-keeping. Again, ask them to contact the Joint  
12 Investigation Team should something happen to you.

15 In any case, it is important to keep your calm and your perspective. All members of  
the Joint Investigation Team are exposed to similar death threats, torture and attacks  
as the victims. We are not asking you to do anything that is more dangerous than  
what we are facing daily. The reason we all have to engage in this exercise and take  
18 the risk of retaliation is that we are faced with the absolute guarantee of non-stop  
attacks with the aim of our death even if we do not act. So there is absolutely no  
benefit in delaying or avoiding action out of fear of getting harmed. Stopping this  
criminality now is something we all have to face up to.

### **13.11 My family forbade me from completing this affidavit as it might put them in danger. What shall I do?**

24 The sad truth is that our research shows that entire families and social networks  
including friends, colleagues and whoever might agree to help the victim, are all  
loaded into these assault programs. The goal is the total extermination of large parts  
of society for the monetary benefit of a vast international criminal network.

27 This goal is being pursued regardless if people can believe it or not, if they are  
willing to face up to that fact or not, and if they feel the attacks themselves or not.

30 In other words, if you are a victim, chances are that your entire family and circle of  
friends has already been loaded into these assault programs but they don't know it  
yet. So in the long-term there is less danger for your family by you helping to stop  
33 these crimes than if you remain silent and the assault program continues silently and  
murders ever more people who are ignorant of its staggering scale.

### **13.12 My family & friends don't believe me. What to do?**

36 The situation we are faced with globally is that our public institutions have been  
taken over by an international organised crime cartel that runs all the drug trade,  
human trafficking, racketeering and financial fraud in the world. It has infiltrated our  
39 militaries, Secret Services, psychiatry, governments, judiciaries and the police. It  
owns most of the arms manufacturers, which it bought up with the vast sums of  
money from large-scale financial fraud and highly lucrative organised crime.

42 Now, it is moving to asset-strip entire nations by executing a global mass  
extermination program to weaken governments and populations. It is using covert  
maiming and assassination with Directed Energy Weapons, crippling of opponents



3 and dissidents with covert non-consensual body implants, nanotechnology poisoning  
and neurotechnology. The weapons it is using on the global population have been  
developed by the organised crime cartel itself through its ownership of the arms  
manufacturers and its control of the militaries and Secret Services of the world.  
These are facts that everyone can check for themselves.

6 In such a situation, you have a huge advantage over your family and friends because  
you have already figured out what is happening. You have likely informed yourself  
in detail, know about modern weaponry and its effects, and perhaps know how to  
9 shield from it. In terms of your research and insights you might be an entire  
university course ahead of your family and friends.

12 This means, that you are the most qualified person to help them. For this reason,  
they have to listen to you in this matter, not the other way around. The situation is  
comparable to when there is an epidemic of an unknown disease, where you would  
listen to a doctor who has studied the disease, instead of those people who don't even  
15 know about the outbreak or cannot face up to its horrendous symptoms and  
consequences.

18 Your best strategy is to remain calm and reassuring and explain what is happening. It  
is likely necessary that you repeat the explanation calmly over and over again. Do  
not be put off by negative reactions of your family and friends. This is not founded  
in logic or counter-evidence, but is due to their helplessness revealed by their first  
21 emotional reaction, incredulity or their grappling with cognitive dissonance as the  
world they have to face up to is nothing like the image that they carried with  
themselves their entire life.

### 24 **13.13 Why do I have to witness my affidavit under oath?**

27 Through the act of putting something in writing, swearing an oath to the veracity of  
your written statements, confirming that it is the testimony that you would give in  
court, and signing it in person, you create a powerful document that is accepted by  
all Western courts.

30 Anyone who disputes your statements would have to do so under oath, and might  
have to prove that you are wilfully giving false testimony. The burden of proof then  
falls on them. If you have a track record of honesty and integrity your affidavit has  
the weight of granite.

### 33 **13.14 Why do I have to send my ID?**

36 Some European jurisdictions require the affidavit to be submitted with a proof of ID  
such as a copy of the deponent's passport or ID card. The photograph together with  
the name and address on the affidavit has to match the information on the passport  
or ID card. In addition, the photo identification is intended to weed out agents who  
invariably will rush to fill out the survey with wrong information or discredit it.

### 39 **13.15 There is much more detailed evidence that I can and would like to give. Where can I include that?**

42 The JIT shall release a long version of the affidavit template to be completed with all  
available details. The current survey only intends to prove the targeting programs.

### **13.16 I would like to help the Joint Investigation Team and I want to help other victims. What can I do to help?**

3 Thank you, your help would be appreciated with the following:

#### **(a) Translating the affidavit templates**

6 If you speak a foreign language fluently it would help us immensely if you could translate the affidavit template into that language.

#### **(b) Help other victims to fill out the affidavit, go public, or go to court.**

9 There are always people who are even harder hit than you. If you could link up with them and bring them up to your level that would help to advance the entire effort. Then they in turn can help others. If you help 3 victims you are doing very well. If you help 10 victims, you are a rock star. If we all do this, we can change the world.

### **12 13.17 Why don't you make an online survey to get easily viewable statistical data on the crimes?**

15 The objective of the affidavits is to use them as supporting evidence in court and to stop the crimes against humanity as soon as possible. So, the main objective is to generate court actionable data.

18 Online surveys are easy to do, but also easy to falsify with fake identities and are therefore not admissible as evidence in court. For this reason, a more lasting format had to be chosen with emphasis on court use by people around the world. Statistical analysis with the current format is somewhat more awkward but still doable.

| Gang-Stalking       | The following of a victim in coordinated groups. This was done by both the East German <i>Stasi</i> and in the FBI's <i>COINTELPRO</i> terror program.  |
| I2K                 | <i>Image-to-Skull</i> , the visual equivalent of <i>Voice-to-Skull</i> (V2K). Military biotechnology using covert eye implants on the lens and potentially also on the optical nerve to broadcast still images, video and virtual reality simulations to the recipient.   |
| Mind-Control        | The control of thoughts, emotions, decisions, speech and any other cognitive function of the brain and high-level features of the mind.   |
| MKUltra             | Covert CIA program of trauma-based mind-control of victims revealed by the Church Commission in the 1970s.  |
