Hi Katherine,

[REDACTED] is a friend of Gerhard Ulrich in Grenoble and he knows well the defaults of the judiciary in Grenoble.

He tells me that my lawyer has already behaved badly with him and with many others in the past and he is well known for entrapping his clients because in reality he works for the judges and the state.

So it's not the first time he avoids an appointment to not talk with his client like he did with me Tuesday evening, and then he sends his legal written conclusions at the last minute to the client and they are very light (only 1 or 2 pages) and he improvises a lot at court with nothing prepared ahead of the hearing and he is a close friend with the judges and since he represents me, he and the judge will refuse to hear my testimony because the judge will prefer to hear only to my lawyer.

And furthermore for the expert witness that you will be :

You have to ask to be heard by yourself and you have to tell the judge which questions you would like him to ask you and he can accept or refuse your questions, and he can even refuse to hear your testimony, specially if my lawyer does not mention the fact that your testimony is important and necessary, so if he keeps quiet about you, then the judge can forget totally to ask you to testify.

But if I am not allowed to speak because my lawyer is representing me and the judge will think it is enough to hear to the lawyer and there is no need to hear me, then only if your testimony could be heard would be the only chance for me to be really defended.

So do you understand the trick they use ?

It is going to be very tough and difficult to get what we want.

It is all a game that they play to me and to us.

And even if I talk the judge can say that whatever I say it is irrelevant because I am not sworn in whereas he is and he will say that what he thinks will prevail on what I may say.

So I am trapped again.

It is the continuation of the entrapment.

[REDACTED] is even thinking that it is not my previous lawyer who could not assume the job of defending me and asked the help to my actual lawyer, he thinks it is my actual lawyer who came to know about my case and who took my case from the hands of my previous lawyer to better entrap me with the judge his friend because my case is a trouble for the state and they want to sack it down the most possibly they can.

Do you have any idea about how to avoid all these traps now that we know about them ?

But it seems a little too late also to take measures and actions against all that.

Hi Katherine.

If I decide to fire my current lawyer, and if I ask for a new lawyer, then there will be 3 problems :

- I may not have the time to find another lawyer, and if I ask for a shift of the date of my court case, the party of the victim and her lawyer will oppose to my request, and the judge may decide to not delay the hearing and to pursue anyway ;
- The new lawyer I may find may be appointed to me at the last minute on the day of the hearing itself, and he will never have the time to read all my legal files that are very numerous, and he cannot defend me properly ;
- My new lawyer may not have sufficient time to prepare the written legal conclusions that have to be delivered in 3 sets to the judge and to the prosecutor before the hearing, and then my defense will be very weak.

Or I can make a different choice : I can decide to defend myself by myself, but then there will be 3 problems :

- I don't know the laws and its articles, so my way of defense will be very amateurish, and not very profitable to my defense, but maybe it is better than being sabotaged by my current lawyer ;
- The judge may refuse to let me speak myself to defend myself, and I will be blocked ;
- I don't know how to write by myself the written legal conclusions about my case, except that I could re-use what I wrote in my court bundle from January and my commentaries about my legal files that I did last week and of course I could also use your report of expertise on my case, so it is of greatest importance that you could send it to me by written format (even if it will not be the final version that you will tell to the court at the hearing) before Tuesday at noon : can you do that ?

So what do you think that I should do ?

If I decide to fire my lawyer I should do it today or Saturday or Monday last time limit from the post office to send the registered letter to him and a copy to the judge and the prosecutor and the others parties (because the friend of Gerhard Ulrich told me that even though he had sent a registered letter to fire the same lawyer that I have now this bastard nevertheless came to the court and he and the judge did the hearing pretending like if there was no firing letter, so it is important to send the proof of that firing letter to everyone in time).
