



81a Male Diagram of Most Common Attack, Pain and Injury Locations




81b Female Diagram of Most Common Attack, Pain and Injury Locations


Note: All body areas highlighted are nerve ending attacks from the brain, the nerve connecting to the nerve area in the body is being attacked via the signal in the brain. This is all available factually to read in various Neuroscience books. The brain holds every nerve ending connected to the body, the muscles, voice, thought process, movement, spinal chord, conscious, nervous system, taste, hearing, visual process, skin receptors, (neurons use electricity to communicate what is happening in different parts of the neuron – Neuroscience for Dummies). Everything I have ticked off as abuse, it can be described in Nazi techniques. Electricity is the conductor for the attack on the nerve endings, the electricity with a radio frequency can be increased, and reduced. (described below)

83 Perpetrators (Anonymous)

The following individuals have committed offences against me. I am listing them **anonymously** to testify publicly about the type of people involved in my abuse.

1 The Nazi abusing family I knew assaulted me in my car radio. This was a family I knew from the age of 25. I will clearly state that the family I knew, are abusers of the sickest kind, they knew me, they attacked me wilfully, to torture and abuse, with sleep deprivation, it's all administered and timed, so any public appearance of my face is to mask what they do to me.

Every medical appointment I have is firstly caused by them, then interrogated to abuse me further to damage my health.

2007

I was told by the abusing woman that one of the men she was dating as a married wife had a radio signal could find me anywhere in the world (I've learned since the attack there is only one type of signal that can operate to do what she described, it's a military frequency signal). The abusing woman (pretending to be a friend) asked for my personal family details, and asked me to email them to her and this particular partner (one of many) could find me anywhere.

This was told to me in 2007. I was in my early thirties and did not know what she meant. This abusing woman is a wife she is a prostitute. This too was not known to me in 2007, it was her secret. This woman lied and lied about her existence to me, there was no way of me knowing she was in a Nazi group and this is a murder weapon, used by the Nazi group that she is a member of. Everything became evident about her and her family via the signal used on my brain over the years. As described below.

Later in the year, she forces me to meet the man she is moving in with, and I speak to him with her for an hour, and it appears staged. Why would I need to meet him, for what reason.

2 2010

I was invited to a party in the abusing family's home in London, and it was attempted to set me up on a date with a man they knew. My gut felt sick, I wanted to leave the party. The behaviour of the family was odd to say the least, they were racists. The family were saying things using NLP, then denying they had said the sentence, and immediately would say 'you misheard'.

2011

Oddly this couple barely spoke to me after the party and through mid-2011. Then I started to receive calls from them to invite me to their home, and see them.

I was told by the abusing woman in the latter part of the year 'they played mind games with a woman I met, and she was told by force to take her life, and they hacked into her internet'. It was a forced suicide (which I learned through my experience of what they were doing this to me to.) I had been set up for the 'new game'.

3

2012

The family I knew asked to date the man they introduced me to in 2010. I dated him for about a month for a handful of times. I experienced a hypnosis when I dated the man, they set me up with. I was told I would be meeting a man via the man I dated. I thought nothing of this.

The family lived in the UK, Cotswolds, they had a room set up with Nazi equipment.

I was tricked into going to their home for a weekend stay, and they as a family were behaving odd, would not leave my side, more use of NLP, odd laughing (their joke). My gut felt sick, I wanted to leave, but they had tricked me into going to their house by train. During the train journey I was asked for my business ideas.

I went on my holiday abroad in the Caribbean and returned home to be met with a barrage of calls from the abusing woman to harass me for details about the man I dated and his friends. I did not know what she meant. They are influential men, she wanted details for her next 'prowl'.

I then started to experience sleep deprivation, and had not linked my car radio to the assaults. The abusing woman and her male friend (not her partner) started to contact me regularly, and I was even told that the abusing man had told someone they knew (who rang me) 'he was challenging me about the man's friend that I dated'.

I started to experience hypnosis about the man's friend that I dated during my sleep, his picture was shown to me during sleep, I did not know the friend. It was odd. Prior to the assault I slept for a solid 9 hours and never experienced hypnosis, sleep deprivation or what I describe.

2013

The abusing family then sleep deprived me severely at the latter part of 2013, and during hypnosis showed me their home, and their faces (they were arrogant) and told me that I did not understand NLP and that why they were doing this to me and then imagine the man you dated, saying 'thank you for not saying anything'. I was in shock, and night sweats that they would be doing what I experienced. At this time, the abusing family were pretending to be the man I dated, and his friends, via the signal (audible to my brain). They as a family were in role play of the man I dated. The really did take on his character, but as I logged this abuse, the characters were out of context on reality of who he is.

I started experiencing extreme heat to my brain, I would scratch my head everywhere, all my friends would comment on 'why are you scratching your head'. The audio to my auditory cortex was now audible in 2013 every day. The abusing family during sleep started to rape me with hypnosis, they would show me their faces and I could/can describe the room in their house. I was being forced with hypnosis commands and manipulated with the direct dialog to

my brain that they wanted me to use my car to drive everywhere and play music, (it was said in a seductive tone. E.g when you drive to the location you will meet the man you dated, his friend). I did drive, I would have driven anywhere to stop the abuse. But what the family had done was manipulated me to drive my car so they could burn my brain further. The abusing family even hacked into my iPhone to play the music that I had on my playlist, to seduce me with music.

It was a radio signal that they own as a Nazi family. The frequency pitch was a silent screech from my car radio was extremely loud, I could feel the heat to my brain, and my nerve endings in the brain would feel like they were all moving. I would be crying, and they as family would be screaming 'get used to this you f*ing bi888'. The frequency was sending electrical energy to my brain, and slowly opening up the secondary auditory cortex, through which sound travels.

I was being abused via the signal to be told it was the man I dated and his friend and they would belittle me in public if I reported the crime. They were able to (still do) come up with hypnosis stories relating to their families to tell me it was them. They then started to pretend they were the government, and higher up. It was not the truth, it is the family I knew.

I started to be shown the real live scenes of the family in their house, chanting abuse at me, calling me names, swearing, telling me to take my life, threatening my family and friends. They would strip of naked and carry out rape hypnosis. The abusing family were acquiring details about my family and friends were acquired from interrogation under sleep hypnosis. The abusing family were shocked that I had read many books, one of the books I had read was about REM sleep. They were as a family taking me into hypnosis in my second stage of REM sleep. I replied to the family you are interfering and waiting for my second REM sleep. To which I received a reply, 'how the f*k do you know about this'.

I was being forced via the signal to wrongly report the man I dated, I had MRI and EEG scans in my brain and a radiology scan on my gut, there was nothing medical wrong with me. They were in role play of the man I dated, to force me to believe this account of events.

2014

The abusing family hacked into my internet, my smart phones, it was all visible to me, I made logs as it was all too obscenely odd. Everything was abnormal from the norm. My internet would go stop working and the restart, my phone would start having images that I had not installed or looked at. I kept being asked to take a selfie (the family had direct access to my pictures on the phone to see my face).

I was forced and forced with the signal to reply back to the family with their brainwashing and brain changing commands. It was forced abusive replies, I was asked for every location I was at, it terrified me. I would be (still am) screamed at with violent threats of abuse, and physical attacks of violence from Nazi people they know.

I started seeing people in cafes, filming with the iPhones and iPads. As soon as I attempted to take a picture of them, they hid from me.

2015

The abusing family signalled me tie in the local town with their sons, I saw them and they just grinned at me, and said nothing to me, it was odd, and this was whilst I drove to the locations and they burned my brain. The abusing woman's son flew all the way from Perth to interrogate me using the system about moving to Perth, and his mother was raping and abusing me. I was horrified that they are a collection of Nazis.

The abusing family kept on telling me to 'text us, meet us and it will stop'. I did text the abusing man to meet up with his partner in the local pub. During the day they using the system to abuse my brain, and one hour prior to meeting them, the signal volume was lowered. I met them and asked them outright if they knew the man I dated, his friend. The man told me no. Small talk was made. Then the abusing woman arrived to meet me, she unusually grabbed my head to kiss it, and then started asking me questions relating to the interrogation she had been carrying out during the day. I knew immediately it was them. I was scared and said nothing. Few hours after I met them, the audio on the sound was turned off, and later in the evening it re-started.

I rang this abusing woman and told her what I could see her family in sleep hypnosis, it was her family, the man I dated and his friend. She told me to see the pscyhitrist and doctor for sleeping tablets. She was conniving for what followed with her and her family's torture towards me.

The abusing family after carrying out sever sleep deprivation, showed me a series of hypnosis dreams described to me, to say how my life was going to be changed, and they had changed my fate for the worst things, to have me killed. They even described still births to me that they could carry out, by stopping the oxygen supply in my brain. The abusing woman is an ex mid wife! She was mocking with her partner and their adult sons, that I wanted to be married and have my family.

The abusing family started to berate the businesses of the business man I dated and his friends, providing me information in sleep hypnosis prior to me knowing, mocking, share price information, forcing me to part with money. In their words 'they were chiselling into my money'. I was told about companies that I had no knowledge about.

I was being told by the abusing man and woman, they were training a wife to be switched on and abused. I was terrified, I would faint in public, fall down, sweating, and break out in skin rashes because they were horribly abusing me with horrific acts of sexual violence towards me and about children, they would describe such horrific acts of violence I would cry and cry, and the abusing family would be sexually gratified by me being upset. They as a family were sexually being gratified with this pain.

The abusing family then started to show me child abuse, and horrific sex acts of violence and tortured me alive. I would be raped on the left side of my brain (with the signal positioned on the left cortex's), with their speech, where speech is abnormal. It was a pain like someone stabbing my brain, it was sharp and extremely painful. I fainted. As I lay down the abusing family told me they would switch this off, what they did was apply extreme pressure to the base of my skull to apply the signal to the severest part of the brain to torture. (review below diagram)

During this year the sleep deprivation was sever (still is), I would be kept awake for days at a time, the worst was for 4 days in a row to have be put in hospital so they could as a family have me sectioned. After 4 days of no sleep and the signal on the left side of my nerve endings in my brain, this affected my speech, as the abusing family did this, they were chanting my family names, one by one. It was a Nazi ritual. It was not, it was the family I knew. The family are so conniving that they even told me to ring M15 to know where they stood with the authorities. The abusing woman rang my phone in the early hours and hung up, as the ambulance came to take to me to hospital. I lay in hospital cold, not able to speak, and not allowed to sleep because the audio on the signal was loud. I was being told to look at my phone and see that it was the intelligence.

In hospital they were chanting the man I dated his name and his friends name to say he was coming to see me. They had hacked into my smart phones to send pictures of the friend on my phones (which they mocked). They then told me that I should take my life.

They were causing severe pain, trying to kill me, and worse they were observing the mental health act, and how they responded to me, via interrogation.

Being a Nazi radio signal (with an extremely high pitch frequency pitch), once the secondary auditory cortex has been burned the radio signal operates in a two-way frequency, I can reply to the abusing family, they can talk directly to me, and show me their physical location where they are, they are arrogant people. They trained my brain by force to reply to them with their administered brainwashing, brain changing command about horrific abuse.

A man was sent to the dating agency I joined, he told me to sleep with an audio under my pillow. It was a random and odd remark. He then too turned up to the abusing families house and used the system on my brain to talk to me during sleep deprivation and showed me his face. He was screaming to me about the man's friend I dated, and forcing me to reply back to him with internal dialog.

2016

The abusing family started to rape my mind in hypnosis to put me in a childlike mind to say they were raping me as a child under the age of 5. It's Nazism to take the victim to a childlike mind to ruin the childhood and force the victim to take their life.

The brainwashing, brain changing commands continued with sever sleep deprivation to keep me awake at night. The Nazi techniques applied to try and kill me were incredibly frightening, they would as a family attack my nerve endings to parts of my body to assault me. I'd be so tired and nap in the afternoon, much to my peril the abusing family were trying to kill me with suffocation techniques, tell me the room I slept in was spinning, they were attacking all my nerve endings in the brain, by forced internal screaming, internal laughing, and pulling the nerve endings connected to my heart to make my heart rate increase. This in turn meant that I had to rely on the little sleep that I was allowed at night.

I reported this crime and I was told by authorities that what I described was not allowed in the UK. It was happening and the family own the equipment. As soon as I received a reply for the abuse being carried out on me, the abusing family moved to Switzerland to continue the abuse with their Nazi military radio signal.

To my horror the abusing family, interrogated about the police and their response, they were observing this, and then did more.

The abusing woman started to interrogate me for business ideas, my product ideas (in current design mode), and interrogated me on how to talk to business men, so she could pretend to be me, take my identity and say the designs are her designs. She even had the audacity to tell me 'she's senior and experienced these business men like this'. She started to interrogate me to ask for business ideas for her sons to take the man's friend that I dated. Told me under hypnosis 'her sons should inherit his money'.

I did not realise (as I was being severely assaulted by them, she was taking my identity to 'pretend to be me to business men')

2017

The abusing families started to describe hypnosis to tell me I could not see the man I dated and his friend and they had taken care of this. I was then dealt their ugly hand of sleep deprivation, and them playing a playlist to my brain of them screaming, screeching and forcing sleep deprivation of only allowing up to 2, 3 hours of sleep per night. The forced brainwashing was for me to hate the man I dated and his friend, it was extremely violent brainwashing/changing. The abusing family did not care if I fainted in public, they did not care about my health. During this year they were telling me they were organising parties for their sons, whilst they raped me. The rape started to show animal pornography. I would wake up night sweats. I was being forced to scream internally, to reduce the oxygen supply to my brain. They also had a 'instant death' technique to halt the nerve endings in my brain and tell me to 'wake up you f*ing b888h'.

I was often woken up at 4am in the morning, for the abusing couple to carry out Nazi sex acts during sleep hypnosis, they would tell me they 'had a nice time' doing this. Then say 'shame we're abusing you, we're used to torturing you, we enjoy our hobby, we enjoy making people squirm for what they want in life'. To add to the abuse, they would show me their faces sat in their homes laughing at me. I was always terrified they are people I knew. So, forth the abuse continued, language that Nazi terrorists use. Such as 'we'll change the keeper, they are good friends of ours'.

2018

The abusing family started to talk about body mutilation all day, to tell me to slice myself. They know how to play the mental health act system, the police (by lying as sociopaths). The abusing woman was now into using the signal to show her sex acts with her partner, and showing her body, she was prostituting herself to be known for sex acts to attract wealthy men. She then coupled this hypnosis with telling me 'she planned another sectioning, and that I would have a duvet wrapped around my head, would be walking down the street, and screaming with the signal on the left side of my brain, your nasty bitch (chanting and Nazism)'. To my horror I researched this, it is a Auschwitz technique used by Hitler in the death camps.

I have this year suffered more sleep deprivation, it happens every night, and during the day they talk with direct dialog abusively, show me their faces being arrogant in the knowledge of the murder weapon they use is not openly discussed and known.

e.g of one night's abuse (logged)

I'm spoken to with vulgarity and sworn at directly with threats made towards me, my family, my friends, their children, the man I dated and his friend and their families (logged). This is usually for about 1 hour. The signal volume is then lowered, I'm then allowed to go to sleep, then I'm taken into hypnosis, and the hypnosis is usually a combination of interrogation, and then covered and masked with threats. I'm then woken up out of hypnosis after 1 hour. Then I'm sworn at by the abusing woman (mainly), then the signal is lowered. I'm then allowed to return to sleep. I'm then woken up out of hypnosis again (usually after another 2 hours). The abusing woman's partner wakes up and joins her to sexually abuse my mind. They collectively will talk about child abuse in intimate details. Then laugh and swear at me. I'm then allowed to return to sleep, and I'm woken up in intervals of 10 to 5 minutes. I feel so tired, and they enjoy turning the volume up and down of the radio signal in my auditory cortex. My eyes sting, and the crown of my head is always heated, as the playlist is playing all day, night, and controlled to sleep deprive me. Then show me their faces, laugh, and say 'it's a cool system, we can control your sleep'.

Hypnosis Chanting (logged)

'say she's pretty' – the abusing woman

'fresh eggs, fresh eggs' (this is a direct inference to ovaries)

'imagine her sons d88k in her backside'

'he came he saw and left empty handed' (direct inference to the son)

'Do you still want your children'

'shame you wanted your family, I took care of you'

'hate your f*ing face, hate your f*ing face, hate your f*ing face (chanted)'

'at least I let you live, at least I let you live (chanted. Inference to abuse and torture my life)'

'women give her these types of details (chanted. It's an inference to business men's details)'

'they all choose her backside in the end'

'I enjoy ruining your day'

'we own your life, your brain belongs to us, you don't need your life'

'my son came he saw he left empty handed, fresh eggs is chanted'

'smoke we'll kill you softly with cancer'

'we'll get you stoned to death'

'I'll f*ing ruin your name, and enjoy throwing acid on you'

'I'll sign your f*ing name off'

'send me an email'

'women give me these types of men's details'

'I'm no one's friend, I get what I want out of life'

'give me your business ideas'

'she's touching her tits'

'give me your f*ing brain'

'your life is dispensable'

Music played to me

They will at night play music to me that I own, and do not own

e.g. of the Day Abuse (logged)

They will speak directly to me, and they will say horrific things to me, that are abnormal to my mind. E.g talk about my body intimately, as they collectively abuse. They find it amusing, they will tell me 'we choose to laugh'. I'm told by them they will have acid attacks made towards my face, and physically have me attacked in the streets, my home burgled, and worse knifed. Worse, they have told they will tell a person with an electrical energy weapon gun to assault me, my family, my friends and their children, with premeditating future planned assaults.

Nazi Techniques (logged and dated)

All the nerve endings in the brain are connected to areas in the body. The heat that is in my brain with the signal, allows the abusing family to attack various parts of my body to create a sensation, my nerve ending attacks connected to the vaginal area are attacked for night and day rape. The nerve ending connected to my heart is often attacked to increase my heart rate and cause anxiety attacks to abuse me. I'm then asked by the abusing family if they have assaulted me in how they wanted to assault me.

Anyone with this awful experience should assess, log and all the attacks, even write up the abuse, monitor their sleep patterns, that is spoken to them, because it's a log of Nazi abuse.

Inference to another person carrying out the abuse, they ask via the signal what can you see, then they reply to say it's that person you can see that is doing this to you, to cause paranoia.

Sleep Interrogation Carried Out

This abusing family took me all the way back to being a child, as young as 3 to interrogate everything, every detail, rooms, homes, content of home, colour of the decorations, the furnishings, people I know, knew, streets I lived in, in details, people's emotions, all aspects of my emotions. Combination of interrogation and hypnosis commands to tell them what I can remember for them to sit and abuse me. Each thing they interrogated about, then was masked with hypnosis to cover their tracks.


The Brain



Attacks on the Brain


Attacks on Areas of the Brain



The auditory cortex was burned with the Nazi signal, via the car radio. It was done as I was listening to music, and the radio station, and the command via the Nazi signal is to 'turn the music up'. As I turned up the music, this is then used to increase the radio frequency (microwave energy weapon) to burn the auditory cortex, primary and secondary. As they burned my cortex, the playlist as then directly being played into my auditory cortex. I learned the car radio operates off satellite radio grid, which my car details was known.



Some Nazi Techniques Used

Technique - Electrical Energy Weapon, Signal Assault

When you listen to the music high this vibrates the auditory cortex, with this weapon the frequency is high and the music is used to mask the burning and the direct dialog being screamed to the brain. The frequency is high and burns the tissues in the whole brain, but predominately in the auditory cortex, and the frequency is targeted on the right-hand side of the car radio speaker, as a driver in the UK the driving position is that the auditory cortex is on the right-hand side. The seduction of 'play more music' is carried out as this burning is carried out, via direct dialog to the brain. The music masks the screeching that is being said to you (like a dog whistle high pitch sound). The victim is being assaulted. In 2015, I had a definitive loud pitch screaming from the abusing woman from the right-hand side of the speaker in my car, as I drove to the station to attend a Show. I had no music on this day. As I make this log, the abusing man says to me 'it depends on how you listen to music'. They must have many ways to interfere with the airwaves.

Technique - Miss the Word

I will process a sentence to say, it can be something I want to say, or I repeat what they as the abusing family have said to me, and they will say 'miss the word', as I talk. This then confuses the sentence that I speak, as when this is carried out, they get pithy enjoyment from doing this as a Nazis to deteriorate the language

Image to Skull

They record sexually explicit acts in their bedroom, sitting on top of each other, and their fingers in their back sides. Then play this to my mind, I am horrified and I faint, at the assault. They even undress, and show all their bodily parts (explicitly), then play them to my mind, in their homes, e.g. standing naked, legs open wide.

Animal Pornography

Sitting in their home, and showing me via the device (iPad), reading out that they are 'raping me, and raping in animal pornography'. They rape with the ape technique under hypnosis, and

then also say 'we've just raped you as a child, now move your legs, you can now go to sleep'.

Technique – Nazi Command with Signal Nerve Ending Attack

The abusing family have a method in which they attack the nerve endings, and it's for their s88ual thrills. E.g. they will attack the nerve in my brain to my vagina area, and then say the command 'move your p888y'. It is said to humiliate me, but they get a thrill out of this, as it to them provides them with cheap thrills. This abuse starts of with them firstly training the mind to reply to them 'how does this feel', when they attack the nerve, 'what did you feel', this is then all combined to abuse, as described.

Technique – Is it the truth or a lie

This is training was carried out from the start, I was forced and forced to say everything I did, do, I mean everything even my bathroom habits. I was then taught by them via my auditory cortex to reply to them to tell them, is it the truth or a lie. The abusing family would repeat this over and over until the answer is in line with what happened. The mind, rightly so, wants to be free of the evil, and will say anything but what they want over and over, they then carry out sleep deprivation to force this command and answers. Each time now anything I carry out, or say, they interrogate with this, is it the truth or lie. E.g. does your face look old now, is it the truth or lie.

Technique – Be Like Us

The abuse horrifically, and it's all to get me so angry, and I do get angry, any sane person being assaulted by them would. They want me to mimic their personality to feign joining in. I find myself replying, I can't help it, it's a forced abuse. They pretend it's to join the cause, it is not, it's to make the victim insane and then play the mental health and police card.

Technique – NLP – I'm Just Like You

This abusing woman throughout the time I've known her, and through this system, is like this. I will do the talking, she emulates my behaviour to suggest she is just like, she is not like me, and she puts effort into convince people that this is the case, and the cycle of abuse continues. As this role play is played out as a Nazi using NLP.

Technique – NLP Tagging Conversation

The NLP dialog in their replies to me in the context of Nazism and their speech is to always tag my internal dialog, positive or negative and they immediately take on the role play of that scenario to start talking, as their reality. This is how they formulate the brainwashing, and brain changing commands in the playlist, then more severely it's their direct dialog for commentary.

Technique – Torture to wake up and sleep

The abusing family have a routine of waking me up in intervals, I'm so tired I choose sleep. Lately in the morning it's in 5 and 10 minute intervals, I'm so tired and they know this so

they abuse more. Keeping me awake generates more electricity in the brain.

Technique – Lowering the signal

A technique that this abusing family use to justify their abuse is lowering the signal, and nearly switching this off for me to hear a distinct radio sound. They then hear my thought process, and I do not think of them, they then get angry, and increase the volume to scream my name, and start abusing again.

Technique – Stopping and Not Stopping – Justification of Continuing

The abusing family have a technique to insinuate they are stopping, not stopping, stopping, not stopping. This is played out like so. I wake up confirm 'they are disgusting and attempting manslaughter', they then reply, 'have our brain back', then this is met with the comment 'do you still want your children'. This broken down is translated to me saying 'they are disgusting and attempting manslaughter', they reply, 'we know we will switch off', then followed by them chanting, 'we have a reason to continue'. The entire language they use to insinuate something for a better result to stop, then justify that we do not like our mindset that your life might improve, so therefore the abuse and torture continues.

Technique - Despair

Today the abusing couple have been playing 'cause despair'. They do this by saying language as 'you should feel disappear, with no one doing anything'.

Technique - Change the word

As I type of the abuse log today, the nasty monster man is sat in his flat playing 'change the word' in my log. He is amused by this, he finds it funny. He is a vulgar nasty bullying evil piece of crap.

Technique - Lift your eyebrows

As they make lewd remarks towards me, I make notes, they don't like some of the sentences I capture as their abuse. They have started to say 'lift your eye brows'. It's said twofold 1) to distract my note taking 2) the blessed wretched woman would like me to age, wrinkles is what she enquires about.

Technique - Commentary on my life, choices

They assume a role of advisory on what I should and should not do, who I can talk to and not talk to, it's nothing to do with them, but they assume, as Nazis.

Technique – Feel insecure

I do not feel insecure, they are murderers as Nazis, it's fact. But what they do here is to say commands to infer inadequacy as a person, as per the racial hatred, they say the following, 'your ugly, you have no job, you should feel despair, we've done this to you for eight years. As it's not normal to my brain to think these things, the mind is immediately jolted to their diatribe comments.

Technique – Tell me about the hypnosis scenario during the day

They play out threats in hypnosis at night, during the day this is repeated over and over to ask me if the threat is valid for them to proceed to approach people in my family.

Technique - Isolation

The abusing family do not just rely on isolation of the victim they choose, they isolate their activity to their family and friends who do this. It appears to allow them total comfort with the torture, abuse and murdering attempts they carry out. The so called 'trust' they say, it is to torture, trust me and I torture you, and don't say anything'. It the torture gets worse, worse and worse. Yet, it can be contained by recording and reporting it, as this shines a light on how evil this torture is.

Technique – hypnosis for spinning around

The woman in 2015 did a technique of raping my brain with child abuse, she then forced a computer image of a hypnosis circle spinning around, she then spoke through how the room was spinning (it's a fast-direct dialog during sleep), and the head feels light, and I fainted in my sleep. She showed me her face with no botox in it.

Technique – Is this a good feeling?

The process here is to force thoughts about them as narcists, then allow the brain to rest with less assault on the nerve endings. The body does immediately feel better that the abuse is not so prevalent (it's only for a minute), then the abusers asks 'does that feel good'. E.g. the abusing woman will say 'see her partner's face'. The nerve ending assault is lessened, and the body calms, and they then ask the question in this technique. This hypnosis is played out during the day when I see people.

Technique - Left Side of the brain accessed

It's a technique they were using on me in 2014, 2015. They raped the left side of my brain, showed me a dark silhouette of their body, then told me they were in my room, shook my head to give a sensation of movement in the left side of my body, so my body moved. They then did the same with saying they were pulling my hair, and my head was shaken up then dropped back down, the entire nerves are jolted in the brain to create this movement. I'm in a semi sub conscious state of mind and I can see the silhouette of their bodies.

Technique - Nazi Rape Hypnosis with Undressing - Gang rape

What this family of abusers were doing and did to me last year prior to me recording my sleep. Firstly, the Nazi abusing family put me under hypnosis to mild sleep. They would undress, and then show me them naked and start talking about raping me, over and over. They would be screaming this to me. I would wake up in night sweats, and would struggle to sleep, they tell me they were raping and raping me, over and over, they would be masturbating over the rape. Their sons would be joining in. It's their gang rape technique. They started doing this more from 2015, each week to amuse themselves. The abusing woman then tried to cover this up with her sociopath clothes stories.

Technique - High and Low Stimulus

The abusing family will often take me through a high and low stimulus to control the mind and it's feelings with their pithy commands. E.g. high = go to the gym = low = shame we're using your money up. They are abusing the mind from it's natural thought process, as Nazis that are evil and spiteful to carry out brain changing. I go to the gym, I always have since I was 24, it is a personal choice. I manage my finances, I work and have worked from 21. They are the epitome of disgust, to cause destruction of life, they do this for amusement. It amuses them.

Technique – Brain Changing – Self Talk

This morning the abusing man said this to me as I'm driving 'shame it's a painful day for you'. It's said in a silent manner in the secondary auditory cortex, and it's said as I make the audio log. So, I say this sentence as if I'm making a comment about them. I don't realise this immediately, but I when I make the audio, I realise that I don't say these things. It is their painful day, and it is their dialog, and their language. It is key to keep a note of my language and their language so there is delineation of the two, as they are demented in their language skills to abuse, and try to change my mind to say things that are natural to them. E.g. they will often say 'say the word f*ing, c88t, bi888, as8 hole, witch'. These words are interjected into the brain changing dialog they use to force the victim to a mental state of break down, as the dialog is not normal to the victim. As the dialog is not normal to the victim (I will speak for myself), the language they use causes upset, and anger, then has a chemical balance of generating heat with anger. The retention of the heat is what the Nazi abuser requires for the signal to continue generating electricity in the brain, alongside a mentally unstable mindset with vulgar language and force behaviours that are otherwise not present. It is visible in my note taking of their dialog, as I make notes, the abusing man and woman will say, use the word.

Some Hypnosis Commands

Interrogated (routine)	Nazi Hypnosis
Showering	Why do you bother
Moisturizing	Tell me about the body part you apply moisture to
Putting on my earrings	You look ugly
Holding my gloves (outside)	Why do you do this
Walking on the street, and looking	She imagines you when they switch off licking the
at the pavement	street

All techniques are dated and logged with me. I log the techniques as they are carried out towards me to torture my life, and I write in the third context of observing what is being carried out to victims of this abuse.
