Dear Katherine,

I didn't want to continue the Twitter thread about this because of all the government offices tagged into it, but I actually feel I'm getting a snowball of revelations about techno crime fighters forum. I don't fully understand your role in things, but I feel that you are a genuine person. I suspect Millicent is also genuine, but suggestible.

However, I now very much believe that Paul Marko, Karen M. Stewart, and Ramola were all connected with some type of disinfo and/or COINTELPRO type program. I mean, I suspect they are all linked to intelligence agencies. I am trying to understand their motivation for doing this show with you and Millicent (was Millicent involved from the beginning?) and I think I'm beginning to. I'm beginning also to understand that people wired head to toe with implants are high value targets - this is why they might completely surround you with convincing skills who's job it is to waste your time and subtly but persistently misdirect you.

I have always had a weird feeling about Marko. I currently have a strong sense that he, like Duncan, does not actually possess a PhD. This appears to be his obituary, doesn't it? <http://tinyurl.com/y5xhd49y> It says he was in the army and American Legion. It doesn't say how old he was, or anything about him having an academic background. Based on the obituary, the distinctive thing about him was his service in the army. If you look for other information about him online, it's like he came out of nowhere around 2011. I truly don't think that the Paul Marko of Pinecone Utopia was the REAL Paul Marko, and I feel the same about Karen Stewart, and probably Ramola as well. I believe ALL of them have assumed online personas and are linked to intelligence.

I feel that maybe some of the nuance behind Marko and Stewart might be harder to pick up on as a non-American, but you also have to look at the theories they've been pedaling and the evidence they have used to support it. With Karen, a lot of her trustworthiness comes from her links and supposed 3 decade history at the NSA. But if you look at her as potential disinfo, none of this is reliable. And she says stuff that really needs to NOT be taken at face value, for example, the stuff about insurance policies taken out on targets and/or 9/11 victims by NSA (she mentioned this in Techno Crime Fighters 1). I don't believe this is real. I don't see how it could possibly be done. There's a lot of other stuff like this, if you start watching carefully. If you're not fact checking everything she says, I wouldn't believe it.

This idea that all these massacres in the US aren't real massacres is a really dangerous idea which I believe being pushed hard by disinformation agents, because they want people to be in denial about what is really going on. It is part of this genocide process. Marko pushed this idea, without providing evidence. This isn't normal logical behavior for someone with a PhD.

I have to think more about the motive behind why they would do a program like techno, but I believe the intent was to create a sort of cull-d'sac for real victims to get stuck in. By adding in a bunch of unsupported stuff (chemtrails, agenda 21 as a genocide plan, real massacres as being false flags where no one dies, etc) they discredit you by association, send you off down the wrong track, pointing to other disinformation sources as valid research, etc.
