Dear Dr. LaPorte,

Thank you very much for your swift reply. While I cannot disclose the identity of my clients, the past and current court cases that I am supporting can be found online along with tons of documentation on targeting, gang-stalking, Directed Energy Weapons, non-consensual implanting and neurotechnology assaults.

One case, for example, reported on in English is the case of Frederic Laroche in France, whose father was a human experimentation subject in a Nazi prisoners of war camp. His brother was a professor of philosophy in France who died a most unfortunate and suspicious death after he had decades-long "Voice to Skull", which is the military communications technology used in field agents and pilots. It turned out that both Frederic Laroche and his mother were implanted with radio-frequency microchips. Frederic Laroche was forcefully committed to psychiatry where his breathing was paralysed with neurotoxins by a set of criminal and highly fraudulent doctors trying to silence him. He was also the victim of an entrapment operation by French Intel who involved him in a stage incident that they claimed was a car accident. They withheld/disappeared the CCTV of the incident. Shortly before testifying in his court case as an expert witness, French Intel involved me also in a staged car accident where they smashed into my car from behind and tried to push me into the car in front to blame the accident on me and disqualify me as an expert witness.

Regarding implanting, there are several ways that implants can be detected: Bug detectors and EMF measurements work on radio-frequency chips implants, of which the typical victim would have several dozens making up a so called Body Area Network. You will also note that the chips referred in that paper are not "wearable" devices like the Apple Fitbit - since no one would strap something both to their wrist, ankle and shoulder - but rather veiled references to non-consensual implants.

Voice-to-Skull (V2K) implants are typically found via the radio-frequency emissions coming from the ear canal or from around the ear, where older versions of the technology would hide the antenna in the fold behind the ear.

Images and entire high-definition and interactive virtual reality movies are sent to victims' eye via covert eye implants. There are several makes of those, which range from contact lenses to sensor containers injected through the pupil behind the lens. One way to make eye implants visible is to shine UV light onto the eye of a victim. When an eye implant is present, the pupil reflects bright green and the iris purple (and often with visible chip readout structure on the iris showing up in purple). Those eye implants would be used to terrorise victims with "hallucinations" that are in fact video footage broadcast to and shown on victims' eye implants. The typical footage ranges from devils, snakes, horror scenes, scenes of violence and even human ritual sacrifice or the murder of pets, children and loved ones.

The overall chip technology on the head and inside the brain is called Synthetic Telepathy in declassified documents of the US military. They allow a complete neurological take-over of a victim including thoughts, emotions, sensory input and limb control. This technology is in the process to be hooked up to AI so that each and every individual can be controlled or crippled at will by their personal AI torture master.

Regarding the gang-stalking, harassment and frequent housebreaking that people report, those are crimes committed by the national and international surveillance networks of the Intel Agencies. The current reincarnation of COINTELPRO is using harassment and brutal physical assault with Directed Energy Weapons to study the remote-control and targeted destruction of the human brain. Victims are slowly tortured to death in the most sadistic fashion imaginable.

For further info, you can find the "Techno Crime Fighters Forum" on Youtube, which was a series that ran weekly for 1.5 years where my colleagues (which included the famous NSA whistleblower Karen Melton-Stewart) and I were talking about these crimes and the international investigation publicly.

After 2 years of investigation, I can confidently say that a significant fraction of the European and American population has been implanted with covert technology. The fraction depends on the category of person, the country and the age group. Intel agents, military personnel and police officers are all implanted. Judges, politicians and journalists are mostly implanted. Children and young adults born in the US after 1987, when Ronald Reagan apparently legalised the implanting of all Americans at birth, are also all implanted. Other parts of the population would range between estimated 30-60%.

So, in a nutshell, if you have children, you should be able to find eye implants in them. Or if you have ever worked on military research projects then you will have ones yourself along with RFID chips in your neck and other parts of your body.

The reason why it matters - apart from the obvious - is that all of this is being used to build up to a genocide of Americans and Europeans. It turns out that our governments have signed Genocide Treaties that require the "culling" of the population at regular intervals. The current genocide plans for the US have been published by a private Intelligence Agency specialising in the monitoring of global weapons sales and can be found here (compare population in 2017 to the Forecast for 2025):

Dear Dr. LaPorte,
