As a former high energy physicist from the University of Oxford and as an investigator of international crimes against humanity, I would like to ask if you are aware and had a chance to read the irrefutable and conclusive evidence that the Sandy Hook Elementary School incident had in fact been a FEMA drill and that it is thus not possible for Noah Pozner to have died as he would have been a fictitious character invented for the government exercise.
