Dear NATO Space Command, dear Swiss military, dear Swiss Secret Service,

At midnight exactly, you have begun machine-gunning my home with DEWs again. By now, you have shot me in the face several times, gunned me through my gums to kill off the root of my teeth, then you have injured my head with shots to neurologically degrade me and now you are gunning my heart. There are loud impact sounds in the building walls around me and shots are also audibly smashing into objects such that I can hear the gunning approach me shot by shot across the room. Games like these are often played by the serial killers among your ranks as they arouse themselves by terrifying their victims to get themselves into the ecstatic mood for mutilation and murder.

By now, it is estimated that a large number of heart attacks, strokes and the like were not of natural causes but rather your psychopathic serial killers rampaging through our communities training a secret army of proletarian degenerates in the mass murder of their neighbours. When on 15th March 2017, I submitted my first request to cease and desist to the Swiss Secret Service in person in their military HQ in Berne, the man I spoke with in a 1-hour meeting there even threatened me with it openly. He said that people have a tendency to get "depressed" and "sad" when it gets foggy in autumn, implying that I might be suicided if I don't let myself be tortured while remaining silent, and then he added that "it can always happen" that people die from heart attacks or strokes, thereby threatening me that I might suffer a similar fate that is easily induced with Directed Energy Weapons. He thereby confessed to my face that the Swiss Secret Service is murdering people at will with complete impunity.

I demand again that you cease and desist your sadistic maiming of my body. And I remind you that the fee for the non-consensual use of my body, such as you are doing, is 100'000'000 CHF (100 million Swiss Francs) per day, whereby the fee is incurred as soon as my body is used non-consensually.

I also encourage all parliamentarians to buy themselves an ultra-violet torch (wavelength 385-400nm) such as this one:

and check if under UV light your pupils light up fluorescent green. I suspect that a large fraction of the parliament and their family members have been covertly implanted, just like the many journalists whom I have scanned. That is because those biosensors in the eyes allow the Secret Services to see everything the implanted victim sees, including sensitive documents related to parliamentary work. The high risk professions where the fraction of implanted people is 50% or higher are:

- politicians
- judges and lawyers (especially commercial lawyers)
- journalists
- police officers
- soldiers and intelligence agents
- · bankers and people in financial services

People in those high-risk professions should scan themselves for eye implants and if some are found also scan all family members, including both your children as well as your parents as the Secret Services implant entire families and social circles. I attach as a reference what my eyes look like under UV light where a modern implant becomes clearly visible. If you are implanted, then the first hint of it is the faint green shown in the darker image. Please also ensure that you don't shine the torch too closely into the your eyes or that of your children. Please also check pets as animals were the first "little spies in the home" to be implanted by the Secret Services around the world.

According to the implant manufacturer Omega Ophthalmics, these implants can be injected into the eye, which means that implanting takes only seconds, see a short video demonstration here: https://youtu.be/M6TQPpRVapc?t=224

It is extremely important that all implants are found inside victims, especially children, as the electromagnetic radiation from these devices degrades the eyes and can cause tumours and cancer with time.

I attach evidence how Nazi serial killers were planted into NATO from the 1955 onwards as reported by the press back then. NATO is thus a covert Nazi killing organisation, which is why they are executing a Europe-wide mass murder of the European population. 
